Since our last, a second return has been made from Brunswick county, giving the whig ticket 156 votes, and the Van Buren ticket 99; which will change the result, as published in our last, a very few votes.

Capture of Osceola.—It is reported, in New York, on apparently correct grounds, that Osceola, the celebrated Seminole Chief, has been captured by a party of Creeks, under Gen. Jesup. The individual Creek, who succeeded in first securing the captive, received \$1000 from Gen. Jesup, and was promoted to a lieutenant.

Santa Anna.—By an arrival at New Orleans it is learned that Santa Anna's irons have been taken off by order of the Texian government, and he permitted to take exercise in the open air, always under a strong guard. The treatment of this distinguished ruffian was very good, certainly much better than he deserved, before he attempted to escape.

Loss of the Bristol.—In another part of this paper we have given a short account of this distressing shipwreck. Further accounts inform us that there were 3 cabin and 60 steerage passengers drowned. The Mercantile Advertiser (N. Y.) says that those who came on shore describe the lamentable catastrophe in terms almost too shocking to record: Mothers calling to their children, and husbands for their wives, and on the next wave they were buried in the deep. The Bristol was signaling for a pilot on Sunday (the 20th ult.) within a few miles of Sandy Hook; and yet the pilots, knowing that no one could interfere with their pilotage—that no competition was allowed—were quietly enjoying themselves in the city of New York.

The Russian government has published a list of 142 noblemen of the government of Wilna, all of whose property is confiscated, for their having taken part in the revolution of Poland.

Bank Robbery.—The vaults of the Oneida Bank, at Utica, N. Y. were entered on the night of Sunday, the 20th ult., and robbed of one hundred and eight thousand six hundred dollars, besides about six thousand dollars in notes and checks. The Directors offer \$6000 for the recovery of the money, and the arrest and conviction of the thief; or \$2000 for the arrest and conviction of the thief alone.

Fire on the Rail Road.—We learn that the warehouse of the rail-road company at Petersburg, was burnt on the night of the 28th ult.; nearly all the engines destroyed; loss very considerable.

Wm. Frick, Esq. has been appointed Collector of the Port of Baltimore, in place of the venerable James H. McCulloch, deceased.

A calamitous Fire took place in Johnston, Montgomery county, New York, on the night of the 25th ult. Loss estimated at \$30,000, but a small portion of which was covered by insurance. It seems the Episcopal Church fell a sacrifice to the devouring element, with its fine Bell, and venerable Organ, presented to it by Sir William Johnson, before the Revolution, and while he was Colonial Governor, under the crown of Great Britain.

TEXAS.—A gentleman passed through Raleigh from the South, a few days since, who announced himself as the bearer of despatches from the Mexican government, which had acknowledged the independence of Texas. We did not see this messenger, and of course have no means of knowing whether he was in reality what he represented himself to be.

MR. VAN BUREN IN NEW YORK. What a contrast the following facts afford with Harrison's run in his own county of Hamilton, where he has been well known from his early youth, up to this moment. He turned the scale against his party in this county, where, but a year ago, they had a majority of about five hundred for their Congressman, and made it a minority of near a thousand against their candidate for the Presidency.

From the Albany Argus. The results of the election in this State, in nearly all its aspects, cannot fail to be a source of pride and gratification to every republican citizen, and indeed to every man who holds its character and welfare in just estimation.

The old town of Kinderhook (now Kinderhook and Stuyvesant), in which Mr. Van Buren was born and brought up, gives him a majority of 288; being double any majority heretofore given for a democratic candidate for Presidency.

The county of Columbia, in which his political career was commenced, and where the greater part of his life was spent, has given him a majority of 717; being more than twice as large as any majority heretofore given for a democratic candidate for the Presidency.

was in the Presidential election of 1832. The City of Albany, the place of Mr. Van Buren's residence for the last twenty years, has, for the second time since its establishment, given a democratic majority for President, viz: 320.

In the second ward of the city of Albany, the ward in which Mr. Van Buren resides, the democratic majority for President is 78; reversing its vote by that majority since 1832 and 1834.

The county of Albany gives him a majority of 686; the second instance since its organization in which it has given a majority for the democratic candidate for the Presidency.

The large agricultural county of Otsego, which remote from the residence of Mr. Van Buren, elected him, without solicitation on his part as one of its representatives in the convention for the amendment of the constitution in 1821, has evinced its continued confidence in his patriotism and capacity, by giving him a majority of 2158 for President of the United States.

The State of his nativity, in the politics of which he has from his earliest manhood taken so prominent a part, has given him by many thousand the largest majority it has ever before given either for President or Governor—not less, probably, than THIRTY THOUSAND.

Legislature of North Carolina.

SENATE. Tuesday, Dec. 6.—On motion of Mr. Bryan of Carteret, the judiciary committee were instructed to prepare and report a bill providing for the biennial election of Comptroller and Public Printer, and prescribing the manner in which the said elections shall take place.

Mr. Kelly, from the committee on claims, reported a resolution allowing George Williamson, late Sheriff of Caswell, \$139, for insolvent polls.

The resolution authorizing the Governor to draw on the Public Treasurer for a sum sufficient to meet the contingent expenses of the Cherokee land sales, was amended, on motion of Mr. Carson, passed its third reading, and was ordered to be engrossed.

Mr. Carson presented a resolution, authorizing the issuing of a land warrant to Samuel S. Gedney, for 128 acres of land in Rutherford county; which passed through all its readings, and was ordered to be engrossed.

Messrs. Moore and Bunting were appointed on the committee of enrolled bills for the present week.

Mr. Edwards, from the committee on the subject, reported a resolution, directing that the two Houses shall assemble in the Commons Hall on Thursday, 15th Dec. 1836, at 12 o'clock; one member of the Senate, and two members of the Commons, to be appointed as tellers, who are to make a list of the votes for Governor as they shall be declared; the result to be handed to the Speaker of the Senate, who shall announce to the two Houses the person elected; which announcement shall be a sufficient declaration of the person elected; and, together with a list of the votes, shall be entered on the journals of the two Houses; which report was adopted.

The bill concerning bodies corporate in this State, was rejected on its second reading.

Tuesday Dec. 6.—Mr. Maclin, from the committee on claims, reported the resolution in favor of James C. Turrentine, and the one in favor of Wm. D. Alexander, without amendment; which passed their second reading.

Mr. Gilliam presented a bill to amend the act in regard to the office of Comptroller.

Mr. Graham, from the judiciary committee, to whom the subject was referred, made a report relative to the act of last session to regulate the mode of passing private acts by the General Assembly; and to ascertain what laws ought properly to be denominated public, and what private acts; committee discharged from the further consideration of the subject, by their own request, and, on motion of Mr. Hawkins, report ordered to be printed.

Mr. Hollingsworth, introduced a bill restricting the term of Cumberland Superior Court to one week.

The bill to emancipate Henry, Fanny, and John, slaves, and children of Miles Howard, passed its third reading, ayes 68, noes 39; and was ordered to be engrossed.

The bills limiting the time within which certain crimes shall be prosecuted, &c. was referred to the judiciary committee, on motion of Mr. J. W. Guinn.

Mr. Moore, from the committee on the Revised Statutes, reported No. 1, entitled a Bill ascertaining the mode of proving book accounts; which passed its first reading.

Mr. Moore, from the same committee, reported a bill concerning wrecks and wrecked property, and a bill concerning public documents; which passed their first reading.

Correction: In the proceedings of the House of Commons on Saturday 26th ult., as published in our paper of last week, an error occurred in the name of Mr. Maclin of Franklin county: the paragraph should have read thus: "On motion of Mr. Hawkins, the name of Joseph J. Maclin (not Joseph J. Hawkins, as our compositor had it) was added to the committee on military affairs."

Again: In the vote for Speaker, Mr. Maclin's name does not appear at all, the name of Martin being substituted for it, there being no such member in the House. Mr. Maclin voted for Mr. HAYWOOD as Speaker. We observe that the other Raleigh papers have fallen into the same error.

Price, of Washington; William Schley, of Frederick; Richard Bowie, of Montgomery; Elias Brown, of Baltimore; John V. L. McMahon, of Baltimore City; Robert W. Kent, of Anne Arundel; John Beckett, of Calvert; Richard Thomas, of St. Mary's; James B. Ricard, of Kent; Thomas Wright, of Tho's, of Queen Annes; Edward W. Hamilton, of Talbot; William Goldsborough, of Dorchester; Thomas K. Carroll, of Somerset; and William W. Furnell, of Worcester.

TENNESSEE AND LOUISIANA.—The N. Intelligencer says, "We think it due to our readers, to publish the following passage of a letter from an intelligent citizen of Louisiana, written in Tennessee, whither he had gone on a visit. "Van Buren, in the Western District, will receive a much heavier vote than is supposed abroad, and I think that Louisiana will give her vote to him: This anticipation is founded on the fact, that the French natives, who compose the Anti-Administration party, are perfectly lukewarm, except when local matters urge them to the polls. Unless Gov. Roman runs, the White candidate, Thos. Mouton, the Van Buren one, will succeed Judge Porter in the Senate."

We would respectfully advise some of the venerable candidates for the Presidency to make application to him forthwith.—Union.

Distressing Shipwreck.—The Ship Bristol of New York, from Liverpool with a cargo of Railroad Iron, dry goods, coal and wheat, in the night of the 20th, in a gale of wind, went on shore on East Rockway Bar, about a quarter of a mile from the beach. She was boarded by the wreck masters, who took off 10 females, and landed them, but could not get back until some hours afterwards, when they took 24 persons; but it is said about eighty steerage passengers perished. Officers and crew saved.—Ship a total wreck. Much blame is charged on the Pilots.

From Florida.—By the steam boat Florida, Capt. Hebbard, arrived yesterday, we received the Jacksonville Courier of Thursday last.—Savannah Georgian, 21st ult. Capt. H. informs us that an express arrived at Jacksonville half an hour before he left from Gov. Call stating that the Army had crossed the Withlacoochee—no Indians were discovered—all their villages had been found deserted;—and that the Army had marched for Yaloussa, where a supply of provisions had been ordered.
