

### DRIVING SNOWSTORM HAS FANNED BISMARCK AND SLOPE SECTION

ed that the gorge was still holding and the river was still rising. Messengers Were Out.

To put people on their guard and give them an opportunity to protect their property Mr. Roberts sent messengers from Bismarck to warn the residents between Bismarck and Painted Woods of the danger should the gorge break.

Other Warnings Issued.

Relative to the condition of the river and the possibility of the Missouri river giving trouble at any moment, Mr. Roberts of the weather bureau, who is section director in charge of the Montana-North Dakota district, made a statement yesterday to the Bismarck Tribune, as follows:

"Warnings were issued by the local weather bureau office, advising residents of the lowlands both above and below Bismarck to remove their live stock to higher grounds and be prepared to move out promptly upon further warning from that office. The following warning was issued to the postmasters at Stewartdale, Glencoe, Livona, Gayton, Hartford, Little Heart, Schmidt, Huff, Fort Rice, Cannon Ball, Fort Yates, Mandan, Harmon, Stanton and Willton. Requests were made to give these

warnings the widest possible publicity.

"The river at Bismarck has been falling for several days, owing to gorges which have formed above. The latest and nearest gorge is located between thirty-five and forty miles above Bismarck. This gorge may break gradually and allow the water to run out slowly, or it may break suddenly and allow the water out in a body. Kindly warn everyone to remove their livestock from the bottoms and be prepared to move out promptly upon further warnings from this office.

"We have no station connected with the weather bureau nearer than Williston, hence constant personal watchfulness on the part of this office is required, and you may rest assured that we will protect you to the greatest extent possible. Please give this matter the widest possible publicity.

"The ice in the Yellowstone river has not yet broken up, but owing to the large volume of water which has run over the ice during the past week the thickness of the ice has been greatly reduced. There has been practically no change during the past few days in the stage of water in the Yellowstone. At Williston the river has been gradually rising for the past three days, due to the gorges which have formed below. The river has been slowly falling at points in the upper portion of Montana.

"While there is no immediate danger at Bismarck, a change is likely at any time and people should be prepared to move out on short notice. This office will keep in as close touch as possible with the situation and will issue warnings promptly."

### BEACH FARMER WANTS BETTER ORGANIZATION

Beach, N. D., March 20.—The Golden Valley Farmers Co-operative company, in connection with the members of the Beach Commercial club and Golden Valley club have been at work some time on a flouring mill proposition.

It is to be incorporated under the North Dakota Co-operative law, and the work of the several organizations will be submitted to the farmers of the Golden Valley in Beach, March 23. A large attendance is expected as the matter has been agitated for some time, and the success that has attended the Farmers' Co-operative Elevator has made the co-operative movement quite popular with the farmers.

Our county was the second in the state to receive a charter under the co-operative law and we believe if the farmers throughout the state fully understand the benefits of a farmers co-operative company there would soon be a change in the management of so-called farmers elevators in name only and not in principal.

In two years business on the prairie plan the farmers have been able to retain, after paying all expenses, \$49,000 to return to the ones who made a profit possible, but these objects are the means of crowding prices up some where in reason to where they ought to be and if the farmers would learn the lesson that there is to be learned when the prices are offered above what the market will warrant and be satisfied to stay at home and attend strictly to their own business, then a farmers' organization will succeed. Otherwise if a premium of a cent or two will get the trade of the farmer his extra cent will soon put his own business on the rocks. Will we ever learn to stand erect and study the situation as it is. We are glad to know the co-operative principles are being studied and benefits are being derived.

It is impossible to obtain a confirmation of the report that the war office had actually sent some kind of an ultimatum to the Currugh regiments that if they protested against serving there, they must either resign, or be dismissed.

D., March 20.—Major Campbell, superintendent of the Cheyenne river Indian reservation, and Chief Clerk Craig report that the Indians are taking up actual farming operations to a greater extent this year than ever before. Farming among them is confined mostly to the raising of corn, alfalfa, potatoes and such vegetables as they may desire.

The removal of the large herds of cattle from the leased pastures on that reserve will no doubt stimulate farming to a larger extent even though the Indian takes more kindly to stock raising than to small farming. The leases expire the last of June, and by a vote of the Indians of the reservation they will not be renewed.

The leaseholders are arranging to remove their cows and young stock, but they will be allowed to keep their beef stock on the reservation until shipping time in the fall, as it would be a hardship to take the animals off in midsummer. But this is the last year of the big herds on that reservation.



### FLOWING WELLS IN BADLANDS

Medora, N. D., March 20.—The ranchers located in the valley of the Little Missouri are having wells sunk. It is found that by going down from 350 to 400 feet a large flow of soft water is struck, which flows over the top of the pipe at the rate of 30 barrels per hour.

W. H. Hanson, J. W. Follis, William McCarty, Sai Ottom and Christ Rasmussen have wells which flow water the year 'round and make watering stock, when the streams are frozen over, an easy thing for the owners. Chris Pederson is having one sunk at his store in Medora. The cost of sinking these wells, including pipe, is \$1.00 per foot.

It has long been known that the valley was in the flowing water belt, the railroad sunk the first well here in 1892, and a second one in 1903.


