
THOS. A. COLLINS

Collections from July 1st 1914 to July 1st 1915, \$545,440. Will collect about \$595,000 this fiscal year. Is married and has never held an office before.




P. O. ENSTAD


CARL LINDBERG


C. E. JOYCE

Collections from July 1st 1914 to July 1st 1915, \$230,518.90. Will collect about \$250,000 this fiscal year. Is not married and has never held an office before.




O. P. ROGNLIE


H. C. HURD


S. J. LERUM


J. W. DUNGAN

Collections from July 1st, 1914, to July 1st, 1915, \$318,118.57. He will collect about the same amount. He is married and has never held an office before.




