SHERIFF NOT LIABLE UNDER THE NEW LAW

But All Others Who Sell Pure Bred Animals Must First Secure Certificate.

FIRST CASE TRIED AT OMEMEE, N. D.

Question of Officers Responsibility Raised by Cass County Sheriff.

Must a sheriff, when he sells some pure-bred stock, at a mortgage sale, have the animals examined and furnish a certificate of health with the certificate of sale? Question Raised Lately. A deputy sheriff in Cass county has written to Dr. Crewe of the Live Stock Sanitary Board to ascertain, if possible, the liability of the sheriff if he issues a certificate of sale. Dr. Crewe took the matter up with the attorney general's office and it is construed that the law applies to all other forms of sale of pure-breds, but that in the case of the sale under a mortgage, the sheriff cannot be held liable.

Law Is Specific. Section 2761. Certificate of Health of Purebred Cattle Required.—All persons selling pure-bred cattle, or cattle represented to be pure-bred, for any purpose except slaughter shall before delivery, make a statement to the state live stock sanitary board on the blanks furnished by the board on application, indicating the number of cattle sold or to be sold, age, and sex, and before delivery thereof such cattle shall be tested with tuberculin under the direction of the state live stock sanitary board, or some person duly authorized by said board, and if found free from disease a certificate of health shall be issued by the state live stock sanitary board to the owner, to be delivered to the purchaser, said certificate shall be valid for one year from date of said test.

Provided, that no health certificates shall be required for animals sold under six months of age, provided further that herds of cattle that have been tested with tuberculin under the direction of the state live stock sanitary board, and found free from disease, no certificate shall be required for cattle in said herd that were under six months of age at time of said test, or born within a year of said test, if sold and delivered within a year from the date of said test.

Section 2. Penalty.—Any person who shall sell or dispose of any pure-bred cattle or cattle represented to be pure-bred for any purpose except slaughter without furnishing a certificate of health as provided for in section one of this Act, shall be guilty of a misdemeanor and be punished by a fine of not less than \$25 nor more than \$50, or by imprisonment not less than 30 days nor more than 90 days.

Fined \$25 and Costs. The first case to be tried under the law for a violation was that of State of North Dakota versus John Burkhardt. It was brought in Eotvineau county and the defendant pleaded guilty to a sale of pure-bred animals without first having secured a health certificate. He was fined \$25 and costs.

\$18,085.00 PAID STATE YESTERDAY. Amount Morton County Owed on Care of Insane Patients at Asylum.

Mandan, Jan. 14.—County Judge C. Johnson went to Bismarck this afternoon to deliver a Morton county warrant for \$18,085.00 to the state treasurer to be credited to the fund of the state board of control.

This is according to the county commissioners the sum total of what Morton county owes for care of insane patients. The bill rendered Morton county for patients' care is in the neighborhood of \$23,000, but the probate judge and other county officials assert that all above the \$18,000 paid is non-chargeable to Morton county, as it is for the care of non-residents of Morton county. The officials declare they will stick by the claims advanced and will refuse to pay any more money.

the former president of their country, who died last night, the prisoner of the American government. Huerta's body, garbed in the showy uniform of a Mexican general, was placed in a vault here today until it can be taken to Mexico City.

Plans for a mass meeting here by Americans to discuss the situation were cancelled today on the orders of Mayor Tom Lea, it being decided that no meeting would be held until trains sent south to bring Americans out of Mexico arrived safely on the American side of the border.

Fifty-two Americans, including a number of women and children, arrived here tonight from Chihuahua City. More than 150 Americans still remained in what is considered the danger zone, but are expected to reach here Monday.
