### PAVING CASE HEARING SET FOR NOV. 24

Action Will Be Tried on its Merits Before Judge Nuessele of the District Court

TO DECIDE IF INJUNCTION BE MADE PERMANENT

Temporary Restraint Asked By Second District Residents Refused Last Month

The question whether there shall be a permanent injunction granted to restrain the city commissioners from carrying out their paving program in the Second district will be determined at the hearing which has been fixed for Friday morning at 10 o'clock in the chambers of Judge Nuessele when the case will be tried on its merits. A hearing for a preliminary injunction was held in September but the application was dismissed by the court. Since then it has been stated that the property owners of the district concerned have amended to a certain extent their grievances, which now allege that the specifications were indefinite, that the contract entered into by the city commissioners was invalid because it delegated power to the city engineer and further because of irregularities in the commission's proceedings.

The commission will be represented at the hearing by City Attorney McCurdy, who will be assisted by Attorneys Miller and Young. The plaintiffs' attorneys will be F. H. Register, R. M. Stevens, Judge S. E. Ellsworth of Jamestown and H. F. O'Hare.




