BECOMES "NO MAN'S LAND"

STRIP OF LAND CLAIMED BY BOTH OKLAHOMA AND ARKANSAS HAS RECORD.

Fort Smith, Ark., Dec. 28.—By a decision of the circuit court here today, a strip of land twelve miles long and two miles wide, adjoining this city becomes "no man's land." The strip was originally a part of the Indian Territory and was allotted to the Chickasaw nation but was ceded by congress to Arkansas in order to allow local authorities to have jurisdiction over it, as it had become a refuge for outlaws. The failure of Arkansas to accept the land by an amendment to its constitution is given by the court as a reason for its ruling, which holds that the line of 1880 is still in effect. The constitutional convention of Oklahoma declared the strip a part of that state.

The property fronts on the Arkansas and Potomac rivers and is valued at two million dollars. Many factories, a million dollar bridge, water-plant and a number of homes will be affected by the court's decision, which holds that all taxes paid for the past twenty years were illegally levied. It is announced that Oklahoma's title to the strip will be disputed in the United States supreme court.
