CAR QUARANTINED IN DRUMRIGHT YARDS SAND SPRINGS WILL ADD TO TOWNSITE

Factory Increase Necessitates More Residence Territory. Constant growth of the town of Sand Springs has made it necessary for the platting of several additions to the townsite, surveys of which are just now being completed. The new additions lie to the west of the original townsite and contain some of the most beautiful of building sites. Enlargement of several of the more important factories at Sand Springs so that their output capacities would be doubled has caused a greater demand than ever for dwellings and properties suitable for home building. A large number of houses has been characterized at Sand Springs since the town's inception. About four years ago, the influx of factories has been so great that the town now has a population of upward of two thousand. Many homes building.
