Allied Civic Clubs and Joe Carson Post Join Hands to Make November 11 a Great Day Here.

ASK MERCHANTS TO CLOSE

Banks, Business Houses and Other Businesses Will Close if Plans of Committee Are Complied With.

Armistice day on November 11 will be observed with a city-wide celebration, according to plans being formulated by the Joe Carson post of the American Legion and the allied civic committee.

Committees probably will wait upon Mayor C. H. Hubbard Friday and request him to issue a proclamation setting aside the day from regular business, as the banks and business houses will be requested to close their doors and provide this is done the oil offices have agreed to do likewise, thus giving their employees the opportunity to properly celebrate the greatest day in modern history.

The celebration will begin at the joint noonday luncheon of the civic clubs and will be followed by a mass armistice meeting at Convention hall, band concerts and other events of a public nature.

SEALED VERDICT IN CASE AGAINST LANTRY COMPANY

Sealed verdict was returned by the jury in superior court last night before which the suit of Huett Hardisty, a minor, by his father, Neal Hardisty, against J. T. Lantry was tried yesterday. The verdict will be open.

The plaintiff asked damages of \$25,000 for injuries received February 12, 1917, when a dynamite cap with which he was playing exploded. The boy's left hand was maimed by the explosion. It is contended by the father that the Lantry company, in operating a stone quarry near the home of the boy, had been negligent where passing school children could obtain possession of them.
