THE ANTHONY BILL

The Anthony bill, pending in the lower
house of congress, which proposes to limit the
number of pages a newspaper may print by de-
signing the second-class mail privilege to any
paper having more than a specified number
of pages, has aroused the ire of the big publishers
who are frantically calling on all fellow pub-
lishers to oppose it. The St. Louis Globe-
Democrat, that rarely of recent years has ven-
tured to express a real opinion on any public
issue, is particularly excited.

The bill, of course, is designed to bring relief
to the newspaper industry from the grave
shortage in news print. And the hundreds of
thousands of country papers, and thousands of
medium-sized dailies, like The World, who have
been following the leadership of the big dailies
in a movement to conserve paper, smile—nay,
grin—as they see the big ones squirm and yell
for help.

The smaller papers are wise, in that they have
acquired some knowledge by painful experience.
They are for the Anthony bill. Let the galled
pates whine, they are the offenders and also the
double-crossers. Representative Anthony has
made a discovery. Let him proceed with the
remedy.

The truth of the matter is (and it has at last
dawned on most publishers outside big circles)
that the print shortage was caused by the
profligate waste of paper by the production of
Sunday magazine supplements and other so-
called "features" by the big publishers. The
issue of the Globe-Democrat containing its
sounding grum against the Anthony bill const-
isted a magazine section of 20 pages. Matter not
necessarily occurring in a daily newspaper at all,
but still within the purview of the periodical
publications.

The excess paper wasted in printing that section
for a single issue of the Globe-Democrat
would have cost The World World for its regular
efficiency approximately one month. These
were the offenders served by the sword. It was
waste, recklessness, indifference, waste. And
because of such waste being constantly practised
by the big papers, which have never con-
sented in an honest, straightforward way, the business
persons and dairy traders of the country and
thousands of communities like Tulsa are put
in a position to suffer.

One of the big dailies comes to the exchange
at 10 a.m. Wednesdays. Not one, of the larger
dailies, the distinguished editions of conserva-
tism, the place their weight together with
the most gaudy broadsides in the nation.

Representative Anthony has been in con-
ference with Tulsa. So no big press or publishing
staff is allowed to sit down. His ideas are
not carried, yet he is extremely conscious.

Just proportion of the postal system, fix up
your bank system on a reasonable protection
basis, and we will be with you.

No paper publisher has any right to special
privileges in a zone greater than his advertising
rates are based on. Let's drive the big ones
back into their corral, and give the indepen-
dent publisher a fair chance to live.
