

NEW REVOLUTION MENACES MEXICO

Francisco Villa May Be at Head of Newly Organized Rebel Band

MAY 7 IS DATE SET

Planned Outbreak to Be Serious Attempt to Overthrow President Obregon

WASHINGTON, April 11.—A serious attempt to overthrow Alvaro Obregon, president of Mexico, is planned for May 7, according to information in the state department today. From George W. Bushnell, charge d'affaires of the American embassy in Mexico City, Mr. Bushnell stated that he was unable to obtain details of the alleged revolutionary plot, but reports of its strength and scope were of such a nature as to make it worthy of serious consideration.

Villa's Name Mentioned.

The name of the leader in the new movement has not been ascertained with certainty but a number of the Mexican generals mentioned among those who may be mentioned in the state of Coahuila with a considerable number of followers, Francisco Villa and Pablo Gonzalez, who was a candidate for the presidency both before and after the fall of Carranza.

Though at one time a favorite of Carranza and urged by the "first chief" as his successor to the presidency, Gonzalez joined the Obregon revolution and led the rebel forces when they entered Mexico City.

He withdrew from the presidential race against Obregon in the interest of peace and tranquility.

Gonzales Is Anti Now.

Gonzales is now quoted as denouncing the Obregon government and hinting that he would accept the leadership of the new revolt.

Reports of President Obregon's change in policy with regard to rebel leaders are causing considerable favorable comment among officials here and have lessened the effect of rumors of the impending revolution. It is believed that a stern attitude will do much to check disorder and may nip in the bud the contemplated revolt.

The general opinion is that the execution of half a dozen "first leaders" in various parts of Mexico within the past two weeks has done much to strengthen Obregon's position, both at home and abroad.

Much of the doubt cast upon the Obregon government, it is pointed out, has been due to his apparent reluctance to live up to his reputation as an iron-handed executive. The alleged prevalence of bolshevik activities and the reported popularity with the radicals of P. Elias Calles, member of Obregon's cabinet, have given rise to suspicion that the Mexican president was not sure of his ground and was resorting to a policy of conciliation where stern measures were necessary.

They learned that after he had done it was a favorite indoor pastime to draw pictures of the clown, how he looked when he did this, and when he did that, and as to what Chow Chow told them about health habits—anything that Chow Chow says goes a long way towards being remembered, believed and practiced.

Chow Chow comes to Tulsa county this week, but he doesn't appear before the children of the city schools until next Monday. According to the schedule arranged for him by Miss Jessie Richardson, executive secretary of the Tulsa Tuberculosis association, he will give his first performance before the pupils at Washington school at 2 o'clock; at 2:45 he will go to Convention hall where the children of the north side schools will hear and see him; and at 3:30 o'clock he goes to Horace Mann. At noon he has lunch with the Kiwanis Club, which is responsible for Chow Chow's appearance in Tulsa. The clown comes to Tulsa Thursday, going immediately to Sand Springs and Broken Arrow for performances. Friday Mrs. Minnette Hodges, county superintendent of schools, will go with him to Jenks and Hixoy, and Tuesday he goes to Collinsville. Saturday he goes to Muskogee for his performance there. Colored school children of Tulsa will have an opportunity of seeing Chow Chow Monday morning at 11 o'clock, when Miss Richardson has arranged for a performance for them at the Dreamland theater, on Greenwood.
