YOUNG MEN HEAR ABOUT SCHWABE

His Candidacy Subject of Junior Chamber Discussion

Although George B. Schwabe, republican candidate for congress from the first district, was unable to address the Junior Chamber of Commerce at Ed Woods cafe Tuesday noon, he was well represented by his friends.

H. Clay Fiske, in charge of Schwabe's Tulsa headquarters, 305-210 First National Bank building, read a telegram received from Schwabe in which he stated the storm Tuesday morning necessitated the cancellation of his speaking engagements.

"Schwabe had made all preparations to attend this luncheon, but the heavy rain forced him to change his plans," Fiske explained.

Charles O'Connor, local attorney, spoke extemporaneously. In his remarks he referred approvingly to Schwabe's candidacy, characterizing him as a brilliant young man.

"We need a bunch of live fellows in congress who are not suffering from brain fog and indifference; we need a change now and then to inject new blood into this body, even though it is too large an organization to function efficiently. Men are apt to stay there so long they lose their aggressiveness."

N. B. Graham, candidate for state senator on the democratic ticket, also spoke kindly of Schwabe. "Although I am on the other side politically, I know Schwabe to be a competent man, Graham remarked.

"He is the only man I know who might cause me to become a republican," he added.

John Rogers, republican candidate for the same office sought by Graham, spoke briefly but did not refer to his candidacy.

FORGET ABOUT HERRIN WAR

Williamson County Grand Jury Not Distracted to Probe Affairs

MAKING, Ill., July 18.—No suggestion about investigation of the recent massacre of nonunion mine workers near here was made by Judge D. T. Hartwell of the Williamson county grand jury in his instructions to a special grand jury which convened today and was charged with taking up the case of eight prisoners held in the county jail here.

Grand jury investigation of the mine war probably will not begin until the next regular grand jury which meets September 25, it was said. The investigation previously was postponed upon the advice of Atty. Gen. W. J. Reudage of Illinois, who said more time was needed to complete a preliminary investigation of the disorders.

Jury Fails to Agree on Guilt of Beaver County Commissioner Charged With Fraud. ALVA, July 18.—After deliberating 24 hours, the jury in this oyster suit against G. S. Mendenhall, Beaver county commissioner, being tried in Woods county on a charge of venue, was unable to agree and adjourned the trial until Monday. Mendenhall faced an oyster suit on a charge of accepting a concrete bridge for Beaver county which he was alleged to have known was not

built according to contract. It was alleged he accepted the bridge to defraud the county. The case went to the jury Friday night after a trial lasting three days. Another trial probably will not be held before the next term of court in October.

Miami Sues Railroad Because It Has Failed to Establish Crossing; Legion Plans Reunion.
