

SCRAP OVER STORE STIRS ENGLEWOOD

Property to Be Measured Before Grocer's Petition Is Acted Upon

A scientific measurement of the square feet of property represented on the petition of Roy C. Meek to establish a grocery store on property owned by the Tulsa Line street in Englewood addition to the north part of the city is being made by Charles Schultz, city engineer, to determine whether the city building inspector acted within his rights in issuing Meek a permit to construct the building.

The matter has aroused quite a neighborhood fuss in Englewood.

Under the city ordinance no person may erect a business house in a residence section unless consent is given by a majority of the persons owning property within a 300-foot radius. The petition for a permit of construction will finally be disposed of at the next meeting of the commissioners.

Petitions to pay and sever all of Weaver addition as presented by W. Frank Walker and Robert Adams, majority owners, were favorably acted upon and the city engineer instructed to prepare the necessary resolutions.

ERROR OF BOMB THROWERS

Blast Set Off in Empty Box Car Short Distance From Explosives.
ST. LOUIS, Sept. 22.— Mistaken by bomb-throwers in selecting the wrong object narrowly avoided what might have been a disastrous explosion on the Missouri, Kansas & Texas railroad last night, it was disclosed by investigators early today.

The bomb exploded in an empty box car, demolishing it. Five cars ahead and five cars behind were two cars loaded with explosives and it is believed the bomb was intended for this section of the train.
