

URGE EARLY VOTE ON FRANCHISE

Give Them 60 Days to Prepare Document, Patton Suggests

The early submission to voters of Tulsa of a new franchise to the Tulsa Street Railway company was advocated at the chamber of commerce luncheon at Hotel Tulsa, Friday noon by Dan W. Patton, county engineer. Patton suggested that the city give the street railway company 60 days in which to prepare such a document for examination, and if this request were not complied with, that a committee appointed by city officials undertake the task.

"This needs a most careful solution of its transportation problems," Patton advised. "In this respect, the public interest is involved. The company wants to handle the traffic of passengers, let it arrive at a conclusion with a body of delegated men in this city and reduce their agreements to the written terms of a franchise which will be equivalent to all put up the proposed franchise to the voters and show to us what lines are to be constructed."

"Let this franchise be payable to the owner, to the extent that fair values will be exacted on the investment. In my opinion, the street railway company has made little effort to get at the basis of this matter in the right way."

Not less than three years would elapse before a franchise and franchise system of extensions could be made, Patton pointed out, and this would leave an interim in which a temporary solution must be provided. He proposed that transportation districts be created and that operating privileges be let to the lowest responsible bidder for bus lines or other means of transportation, and the revenue therefrom be used for street maintenance.

"Certainly," he added, "this would bring competition, and increase the city's revenue." It also would eliminate the charge of favoritism as is now from some quarters flamed at the city commission, and the plan is considered feasible. The bus system could be continued even after street railway extensions were made, serving patrons not within reach of street car lines.


