PRIVATE ROOM OR- DINANCE

ORDINANCE AS AMENDED HAS BEEN ACTED UPON BY COMMIT- TEES AND WILL BE REPORTED MONDAY NIGHT.

At the next meeting of the city council which will be held on Monday evening next among the several matters to come up is that of the new ordinance regarding private rooms in saloons and restaurants. At the last meeting the ordinance was brought up but an amendment was proposed and the bill referred to the health and police committee. The committee has met and prepared the bill for final action by the council and it will come up for action as above stated.

The ordinance as it now reads prohibits the sale of spirited or fermented liquors, where sold in quantities less than one quart, in any side room, back room or alcove or other room in such saloon, bar room or restaurant; nor shall any sign be laterated that indicates that any private or separate entrance be for any particular class of customers, ladies, families, etc. Hotels having a valid license to sell liquors can furnish liquor to their guests. In the meaning of the ordinance a hotel is a place where meals are served, a register kept for signatures of all guests and which has 25 rooms or more for lodging.

Restaurants where spirituous, malt or fermented liquors are not sold or where private rooms are entirely open facing any hallway, passageway or room and the side rooms do not exceed seven feet in height are excepted from those provisions forbidding private rooms. The penalty for violation of the ordinance is fixed at \$100 or imprisonment for 30 days. There is no doubt that the ordinance will pass as amended.

"A TEXAS RANGER."

the jail, and in their cells they continued. The complainants all declare that they o'clock in the morning. Following a custom which the sheriff says has obtained for many years in Waukesha county when prisoners are unruly the garden hose was turned on them, but even this did not dampen their ardor. It is the boast of the Jumpers that the more they are persecuted the more joyful they become.

On June 8 the 17 returned to jail in default of fines of \$2 and costs, and the street meetings were resumed. On the night of June 26 two women members who had been repeatedly warned were arrested, and the next day F. M. Messenger, one of the heads of the organization, was placed under arrest. Two days later six \$5000 damage suits against the sheriff were started and others are threatened.

The complainants all declare that they are divinity students and that they were in the peaceful pursuit of learning and experience when they were arrested. They charged that the sheriff and his deputies pummeled them with clubs, and that later when they were at prayer and were carrying on their petitions in an ordinary tone of voice the sheriff turned the hose on them and drenched them to the skin.

In the court cases following the arrest of the Jumpers the county was forced to bear the expense of the defense as well as of the prosecution, even the witnesses for the defendants being secured at the expense of the county. The prisoners filed affidavits of indigency, stating that they had signed over all property to the association on being admitted to membership. Their defense consisted largely of the citation of scriptural verses, frequently allusion being made to one in Psalms, "Cry aloud; spare not; raise your voice like a trumpet."

PROBATE BUSINESS.

The administrator of the estate of Mary B. Cook has petitioned the county court to be allowed to sell real estate in order to raise money to pay debts of the estate and administrator's fees. There being no heirs at law, Monday, September 16, at 10 a. m., was set as the time for considering this petition and all persons interested are cited to appear at that time to offer objections, if any, to granting the petition.

Frederick Balmer, administrator of the estate of Emil Balmer, deceased, his final account and citation was made and September 16 at 2 p. m. set for action on same.

He was particularly interested in the system of keeping municipal accounts and having heard the Astoria methods highly spoken of investigated the local system. He called on Auditor Anderson yesterday who gave him full information regarding the matter. Mr. Greenbaum made an exhaustive examination and was highly pleased with the result. In speaking to an Astorian reporter at the Occident Hotel last night he stated that he was so well satisfied with the methods followed here in municipal book-keeping that there was no doubt but that the method would be adopted in Salem. Being an expert accountant he is a capable critic and his opinions on such matters have great weight with his conferees in Salem's city government.

What particularly struck Mr. Greenbaum's fancy was the simple yet accurate system of handling the city's accounts. By the system used the auditor checks up his own accounts as well as those of the chief of police and city treasurer and every dollar handled by each of the officers is easily and quickly accounted for. Several other fine features are shown and Mr. Greenbaum has made notes of all of them for reference.

Mr. Greenbaum is also enthusiastic over municipal conditions in general, and speaks of the fine public buildings and the permanency of all improvements made showing great by the enterprise of Astoria people.
