WILSON POLICIES TESTED IN TEXAS AUGUST NINETEEN

Austin, Tex., Aug. 11.—Are President Wilson's policies unpopular among the democrats of Texas? This question will be answered in a run-off senatorial primary in this state August 19.

Word comes from Washington that the administration's policies, including the Wilson administration—including Postmaster General Albert Burleson and Attorney General T. W. Gregory—and democratic leaders of national prominence regard the senatorial situation in this state as extremely threatening in the matter of having an influence upon the voters of other states.

Nothing will be left undone by the national administration and party workers to bring about the defeat of Mr. Colquitt in the second primary. It is stated that a number of campaign speakers of renown will be sent to Texas to try to arouse the democratic voters into supporting Senator Culberson.

So far as can be learned Col. E. M. House, who in times past made and unmade governors and senators of this state at will, took no part in the preliminary senatorial campaign, although he is known to be a warm supporter of Senator Culberson.
