SAD POISONING CASE IN MIDDLE BURG.

An Old Man Sixty Years of Age Commits Suicide. On Saturday night last an old man, about sixty years of age, named Matthew Gardner, residing in Middleburg township, committed suicide by swallowing poison.

The deceased was small frame in build, thin, and had a long white beard. He was a native of Ireland and had resided in this country for many years.

On Saturday afternoon Mr. Gardner went to Berea, intending to purchase dry goods for coloring. At Berea he met several of his neighbors and seemed in his usual good health and spirits.

On his return home about ten minutes later he was found lying on his back in a room, apparently in a state of unconsciousness. He was taken to the hospital, but died shortly thereafter.

The coroner's jury returned a verdict of suicide. The cause of death was determined to be arsenic poisoning. The body was buried in the Berea cemetery.

It is believed that the deceased was suffering from some ailment, and that the poisoning was the result of a mistake in the preparation of a medicine.

The case has attracted considerable attention in the neighborhood, and the authorities are taking steps to prevent similar occurrences.

The coroner's report will be made public in a few days. The case is being handled with discretion and sensitivity.
