Santa Monica Items. The brig Tanner left the wharf last Friday, for San Francisco, with 250 tons of bread.

The steamer Orizaba, on her down trip last week, discharged 350 tons of freight at this port. This is the largest cargo for some time.

A huge whale made its appearance one day last week, and floated around for awhile between the wharf and the outer buoy. Several gentlemen were on the wharf at the time and had a good look at the monster.

We were surprised at a statement made by an officer of the Ancon last evening. He said that the beet of Oregon is more inferior to that of Southern California. The difference was so marked that all on the vessel noticed it. This rather "takes the wind out of the sails" of parties who have repeatedly told us that Oregon is the finest cattle country in the world.

We had a pleasant chat last evening with Mr. Buckingham, purser of the steamer Ancon. He has been on the line from San Francisco to Portland for the past eight months. His run up the coast has been a rather hard one—rough seas, and rain, rain, nearly all the time. He says he experienced the most delightful change as soon as he got south of Compton, Southern California. With its drouth, he thinks is preferable to Oregon, with its overplus of rain. And he added, a little enthusiastically, "I tell you Santa Monica is bound to be a great resort for the winter months. It has no place on the coast as all comparable with it."

Tea Culture in America—Views of an Expert. THE WHOLE TRACT IS LEVEL. Only sufficiently inclined for good drainage.

NEW YORK, March 19th.—A Tribune Washington special says: A gentleman connected with a prominent tea importing house in Baltimore, and who is an expert on all matters pertaining to the culture and curing of tea, came to Washington last week, by appointment with the Commissioner of Agriculture, to inspect 100,000 tea plants growing in the vicinity of Compton, the Agricultural Department.

This gentleman has traveled in China and Japan, in connection with the business of this firm. In the latter country he has seen the season as superintendent of the plantations and curing and packing establishments owned by his house. He is therefore probably as well qualified as any American to pronounce upon the practicability of cultivating tea in this country.

He expresses the utmost confidence in the success of the Commissioner's plans, and is surprised that tea culture did not long ago have an available branch of American industry. The gentleman further says that in his opinion two-thirds of the labor expended in China is useless, and that with one-fourth of the equipment displayed in the invention of the cotton-gin, machinery can be devised here which will supersede every hand manipulation except that of picking, and that we can produce results of a quality of better quality than can be otherwise arrived at. He recommends to the Commissioner that in future documents on the subject of tea culture Oriental accounts be disregarded, and that a plan similar to the principles which govern the preparation of tea be substituted. Processes that would suggest themselves, he thinks, to intelligent experts, all the above mentioned mystery which has clouded the whole question of American tea production principles.

Bank in Boston on the Boston Savings Bank Run—What it Proposes. CHICAGO, March 18.—A Journal Washington special says: General Butler, in his report on the run on the Savings Bank in Boston, and the passage by the Massachusetts Legislature of a stay law to stop payments of savings banks said: "I hope nobody will put this enormous suspension of payments to the credit of the silver bill or silver dollars, which now, so far as they have gone into circulation, have been at a premium on gold, and the bonds will be sold so that the bank could have sold them before the passage of the silver bill, and for more than they could before. What has happened in Massachusetts will be repeated by other States, almost immediately, and it may become necessary for Congress, as it is possible they have the power, under the constitutional provision, to make a uniform system of bankruptcy to pass a national stay law. Certainly they will have to do it unless some measure of relief comes."

General Butler, if he can get the floor to-day, intends to offer in the House two resolutions to remove their passage until suspension of the rules. The first is to instruct the Banking and Currency Committee to report a bill to withdraw subsidiary silver coin from circulation, and to issue in lieu thereof fractional currency. The second resolution will instruct the Banking and Currency Committee to report a bill directing the Secretary of the Treasury to suspend the current expenses of the Government twenty million dollars in one dollar, two dollar and five dollar notes.
