GENERAL CLEANINGS

Sam H. Rohn, a plumber, was shot and instantly killed Monday evening at San Diego by G. L. Gidney, a Deputy Constable. Gidney was bending over a drunken man in the street at the time, and Rohn, saying he thought it was a friend of his, stepped up and shot. Rohn continued to advance, when Gidney fired the ball passing through Rohn's mouth and penetrating the brain. Gidney is in custody. Rohn was married about six weeks ago, and is spoken of as an industrious man.

A desperate conflict occurred on Sunday at Jellico, Tenn. Marshal Woolwine undertook to arrest some miners for disorderly conduct. The men resisted and one of them, Noah Miller, was killed. The others fled. At night the miner's friends attacked the Marshal and killed three and wounded two of his posse.

Secretary Whitney has returned to Washington in improved health. He was at the Navy Department a short time Monday, and afterwards called on the President. He will not take an active part in the management of the Navy Department for some days.

There was frost and thin ice at Tampa, Fla., Monday morning, closing the epidemic, which had already about died out. Ice was seen Monday morning, but the weather was not cold enough to do any injury to the oranges. Tampa is jubilating.
