

THE SEWAGE.

More Evidence Heard by the Commission.

The Sewer Commission met yesterday morning, O. N. Wells in the chair, and Messrs. Hansen, Ferguson, Culver, Knox, Workman, Sinsabugh, Breed, Hamilton, Frankenfeld, Judson and Brown present.

The meeting was called at 9 o'clock, but it was nearly 10 o'clock when the proceedings were opened by the Chairman, who stated that the meeting was, properly speaking, a meeting of the sub-Committee on Utilization of Sewage.

Mr. J. A. Pirtle stated that he had a number of affidavits of physicians relating to the use of sewage for irrigation. He asked that he be allowed to read them.

Ex-Mayor Workman moved that they be read.

Mr. Knox objected to the reading of affidavits on the ground that the commission could not have the opportunity of questioning the physicians, and thus arriving at a correct idea of the matter.

Mr. Breed moved that the commission go ahead and hear the testimony of those who were present.

Mr. Sinsabugh said that there were witnesses present who had come a long way, and these should be heard.

Mr. Breed's motion was carried. The first witness was H. N. Franklin, who said that when he moved to Wilmington avenue his neighbors were all using the sewage matter, and he was surrounded on all sides by the sewage.
