Burglary, Divorce and Local News Noted at Santa Ana.

PASADENA, Feb. 27.—The city council met in regular session this afternoon, all members present, in the council chamber, in the Hopkins block, and a resolution was passed declaring the White building, corner Fair Oaks and Union streets to be the official city hall, and designating the room to be occupied by the city trustees.

A property owner on Grand avenue appeared before the board and asked that a resolution of intention to complete the portion of sidewalk remaining unaid in front of Mr. Rosenbaum's property be passed. The city attorney was instructed to prepare the resolution.

The long drawn out license ordinance next came up and proved the subject of contention. This unmanageable ordinance was taken up and amended and remanded until but little of the original remained, and finally on motion of Councilman Cox a resolution was passed that the entire ordinance be wiped out of existence, President Weed alone voting no and McQuilling not voting.

A resolution of thanks for recent hospitality was received from the members of the Salt Lake City council and ordered spread upon the minutes. The report of the city engineer recommending the grade to be established on Bellview drive, from Pasadena to Fair Oaks avenue, was accepted and ordered on file.

Action relating to establishing a grade on West Colorado street was deferred two weeks.

The license ordinance now again appeared upon the scene in the shape of a motion to reconsider the vote to abolish the ordinance, all members voting in the affirmative excepting Councilman Clarke. The time for action was deferred one week to give all parties interested a chance to register their petitions.

A motion to adjourn until tomorrow at 3 p. m., at which time the question of water rates will be taken up, was passed.

An Interesting Craft—Local Affairs—Hotel Arrivals.

REDONDO BEACH, Feb. 27.—A visit on board the bark Highland Home is replete with interest and your correspondent spent some time this morning with Capt. McWhir, learning many points regarding his fine craft and a casual extract from his log.

The bark Highland Home is registered A 1 first class in all respects. She was built in Leith, Scotland, six years ago, is of 1298 tons register with a carrying capacity of 2300 tons. Besides the 1500 tons being discharged at this port she has 700 tons of freight for Portland, Oregon.

Capt. McWhir reports a fine passage from Antwerp, 128 days from Flushing, the outer port for that city. He crossed the equator in the Atlantic 26 days out from Flushing and rounded Cape Horn 48 days later. He met light winds and calms in the South Atlantic, striking several severe gales lasting 10 hours. In the vicinity of Cape Horn he spoke several vessels, mostly homeward bound.

The run on the Pacific was attended with light and pleasant weather, crossing the equator on the one hundred and eighth meridian January 26. From the equator home light winds and moderate weather into Redondo port. The captain looks clear for Portland in about a week.
