SAY HE MARRIED HIS SERVANT. Charles Langford's Children Want a Redistribution.

The Story of an Elopement, a Divorce and a Marriage.

A Wife Divorced by Her Husband Without Her Knowledge, After Which He Marries His Servant and Leaves Her His Property.

The contest over the will of Charles E. Langford, deceased, bids fair to eclipse in the nature of the evidence adduced, the sensational features of the late Bradbury vs. Millet suit.

The case came up for hearing yesterday morning before Judge Clark and in jury department two of the superior court.

The defendant in the suit is Mrs. Marie Langford, and the contestants are seven children of the deceased Langford by a former wife: Eliza Longebore, Charles E. Langford, Thomas O. Langford, Edwin O. Langford, Mrs. Annie Finch and Mrs. Helen Finch.

Langford died last June in Pasadena, leaving an estate valued at \$75,000. In his will he left to his wife Marie the estate in Pasadena and \$20,000 in cash.

He also left \$1000 to each of his seven children, should the estate be worth \$7000 after the provision should be made for the wife.

To his one child by his present wife he bequeathed all the property which his mother should be possessed of.

It appears from the papers filed by the contestants that the deceased's present wife was at one time a servant employed by Langford's first wife, at a time when Langford resided in Illinois.

The contestants allege that while employed in the family as sempstress Marie won the affections of the old man, and induced him to go to Chicago and institute proceedings for divorce against his wife.

The divorce was obtained without either the knowledge or consent of the then wife, and within two months Langford married the sempstress, Marie.

The contestants also state that Marie then induced the old man to remove to Pasadena, where they would be unknown.

The children followed, however, and settled down in Los Angeles.

The complaints allege that Marie, not content with the spoils already secured, used all sorts of machinations to prevent the children seeing their father; also that she poisoned his mind against them by declaring that they hated him on account of his action in obtaining the divorce against their mother.

It is alleged that the will was signed under undue influence, at a time when the testator was 70 years of age and feeble minded.

They also declare that as the property of the deceased was accumulated during the time of his marriage with the first wife, that the will should be set aside, and the property distributed according to the laws of inheritance.

No witnesses were examined yesterday, the time being taken up by impaneling the jury and in arguing as to the admission of certain preliminary evidence.

The case promises to be an extremely interesting one, if the evidence at all compares with the nature of the allegations in the complaint.

PROTEST AGAINST A GRADE. Property Owners on Hinton Avenue Make a Vigorous Kick.

A protest was filed with the city clerk yesterday by Charles N. Smith and other property owners on Hinton avenue against the grade fixed for the street between Beady and Pearl streets.

They claim that the grade is out of all proportion to the natural grade, and inconsistent with their rights.

They say that if it is kept as at present it will amount to a confiscation of some of the property; that it will necessitate the filling in of lots adjacent to the street several feet in depth, in some places as much as six feet.

They also say that a grade can be made which will make the street much better, will necessitate considerably less filling, and save the property owners a large sum of money.

They assert that their petition contains a majority of frontage along the line of the proposed grade.
