CHICAGO GRAIN MARKET LOCAL STOCKS AND BONDS. Wheat Opened Weak but Closed Strong—Corn Lower. CHICAGO, May 20.—Strength in the wheat market was not in evidence at the opening. On the contrary, sentiment was somewhat bearishly inclined, owing to weather reports from the northwest. A liberal increase in receipts at Minneapolis gave encouragement to bears. However, the steady tone of cables in the face of a break here, yesterday almost offset the bearish influence. Current quotations on wheat were a shade to 1/4c lower, at 86 1/2c/87c. On reports of additional rain in many portions of the southwest, a good demand developed.
