SENDS BULLET THROUGH HEART

MRS. H. M. MORRISON ENDS HER LIFE

DESPONDENCY CAUSE OF ACT

Young Woman Finds No Joys in Life to Make It Worth the Living, and She Resorts to Suicide

Because she was despondent and could find no joys in life to make it worth the living, Maud Morrison, the 23-year-old wife of Harry M. Morrison, shot and killed herself in her home at 1365 East Fifty-first street some time yesterday morning.

Mrs. Morrison had been married but two years, and though she and her husband had apparently lived happily together the relatives intimate that there was an underlying something that made the young woman's life a sorrowful one.

Two weeks ago Mrs. Morrison attempted suicide by taking a quantity of chloroform. She was found by her mother-in-law in an unconscious condition, and was only resuscitated after the strenuous efforts of a neighboring physician.

Yesterday morning about half past 6, when Morrison left his wife to go to work, he says she appeared to be in excellent spirits, and nothing was further from his mind than that she should take her life.

Doors Locked and Windows Closed
About half past 3 he returned to his house but found the doors locked and the windows closed. He thought his wife had taken their 1-year-old baby to his mother's house, a few blocks distant, and hurried there to join her.

He was greatly surprised on his arrival at his mother's to find that his wife had not been seen during the day.

Worried with apprehension, he returned to his own house and broke the door in. As he entered the first sight to greet his eyes was the body of his wife lying in a pool of her own blood upon her bed.

The woman had placed a 38-calibre Hopkins & Allen revolver to her heart and pulled the trigger. So closely to her body did she hold the gun when it was discharged that her garments were partially burned.

Mrs. Morrison left no note or word of any kind that might lead to any reason for her act. She was a native of Kentucky and came to California in 1886. She was married to Morrison in October, two years ago, and leaves one baby girl less than a year old.


