Mrs. Evelyn Fletcher-Copp of Boston, Mass., the originator of the Fletcher music system which has gained a worldwide reputation, arrived in Los Angeles yesterday. The Fletcher system has been welcomed all over the land by mothers who have grown weary of forcing children to practice their music lessons, and the woman who originated the system has traveled in many of the countries of Europe introducing it. Children are taught by means of various games, first taught to distin-

guish sound and are then given signs for the various sounds. They are taught to read music, to build the major and minor scales, to use the fingers, wrist and arm and to develop the muscles before they are allowed to touch the piano. Mrs. Fletcher-Copp has just returned from London and is on her way to San Francisco and Portland. Monday morning at 10 o'clock she will give an informal talk at Kramer's hall to music teachers, educators and parents interested in the study.

FEAR TROUBLE BETWEEN RUSSIANS AND JAPANESE

RAILWAY EMPLOYS SUBJECTS OF WARRING NATIONS

Gangs of Laborers on Repair Work Daily Coming Closer and Citizens Along Line of Los Angeles-Pacific Expect Hostilities When They Meet

While a treaty of peace is being drawn between Russia and Japan by envoys of the warring nations at Portsmouth and while hostilities in the far east are at a standstill, the cloud of war is hovering over Los Angeles and residents along the line of the Los Angeles-Pacific railway are awaiting in dread the time when the Japanese and Russian employes of the company start hostilities. The strained conditions along the line of the road have been brought on by a recent act of the company in hiring a large number of Russians to repair stretches of track in the neighborhood of Venice and Ocean Park. For the past two years it has been the policy of the company to hire Japanese for all road work and several score of the little men, typical soldiers of their country, are now employed along the route. About a week ago a number of repairs and the laying of a large stretch of track in the vicinity of Venice was begun, and because of the lack of Japanese laborers the company was in a quandary as to where to get laborers. As a last resort, a colony of recent arrivals from Russia was approached and more than a score of the men consented to work on the track. The new laborers are fine types of Russians and retain their eastern mode of dress. When a little Japanese workman was taking a holiday at Venice several days ago he noticed the enemies of his country at work on the road, made a dash for his own countrymen at the other end of the line and much discussion resulted. The Russians do not know of the existence of the Japanese along the line and the Japanese refuse to make any statements, but a strict watch is kept as the two gangs draw nearer together in the work of repair, and when the bushy beards of the subjects of the czar appear interesting developments may follow.
