### Picnic Party Struck by a Car Dashes Into Wagon Load of Children

Accident Takes Place at a Grade  
Crossing Near Southport, Ind.  
Three Probably Fatally

The dead: JENNIE RUSSELL, 10 years of age. HARVEY JAMES, aged 10. The severely injured: Fred Kipe. Mrs. Sadie Russell. Lydia Morrison.  
At the place where the accident occurred is a sharp curve at the top of a hill which hid the wagon from the view of the motorman until it was too late to stop the car.

### M'ADOO DETERMINED TO REGULATE TENDERLOIN

#### TALKS VIGOROUSLY TO MEMBERS OF POLICE FORCE

Scathingly Arraigns Those "Captains  
of the Industry of Vice and Crime"  
Who Grow Rich in Their Nefarious Trade

NEW YORK, Oct. 22.—In order to correct an impression that the police of the Tenderloin section had been instructed to arrest unescorted women found in the streets at night, Police Commissioner McAdoo visited the station house tonight and made a long address to the force. He read the sections of the law on the subject and told the men that he expected them to arrest all improper characters, but that the mere fact of a woman being alone did not justify her arrest and that he would deal severely with any policeman found interfering with a respectable woman. The commissioner said in the course of his address: "No one's rights will be illegally interfered with, but this precinct can and will be made clean. There are no difficulties in the way which cannot be overcome with legal methods. This precinct is in the very heart of the commercial and social capital of the Western hemisphere. It is a disgrace to the city, its morals and civilization, that such an ulcer spot as this should exist in the very center of its greatness."  
"We are bound not only to protect our friends, but the army of visitors from these corrupting influences and unseemly sights."  
"You are combating great influences in enforcing these laws; the owners of the property who reap large profits from the basest criminal uses to which it is put; the various business interests which thrive on profligacy and who complain that with them trade is dull, and, lastly and more potent than all these, those who grow rich in crime and vice, vice to whom it is a legitimate industry, whose millions are stained with the blood and tears of wretched women and outcast men, who own the large Raines law hotels where the woman in first robes of the price of her infamy and when she is arrested, compelled to pay them for the bond that releases her."  
"Rich and influential, swaggering and blustering, these Captains of the Industry of Vice and Crime reach out their influence into the most unexpected quarters. They do not want a police captain here whom they cannot own, and even now they and their hirelings are threatening political disaster to the honest head of the city for maintaining in office a police commissioner who is not afraid of them."  
The commissioner exhorted the men to be loyal to their commander, Captain Dooley, in whom he said he had the fullest confidence.

### SCIENTIST ENDS HIS LIFE

About a year ago Prof. Judd, owing to mental trouble, lost his government position. He was sent to an asylum, where, after having been treated for melancholia and homicidal mania for about ten months, he appeared to be much improved and was discharged about two weeks ago.

### COINERS NOW ON AMERICAN SOIL

#### REACHES PORTLAND ON WAY TO SAN FRANCISCO

Shows That He Has Been Under a  
Terrible Strain, but Asserts  
Confidence He Will Be  
Acquitted

PORTLAND, Ore., Oct. 22.—George D. Collins, who for the past three months has fought extradition from British Columbia to California, where he is wanted to answer to a charge of bigamy, arrived in Portland late tonight in charge of Detectives Thomas Gibson of San Francisco and tonight started on his way to the California city.  
Collins showed glaring evidence of the tremendous strain he has been under since he left the United States and is scarcely a shadow of his former self. He departed from San Francisco a hale, robust man, and returns thin and emaciated, his clothes giving the appearance of garments built for a man much larger than the wearer.  
He still maintains an unbroken spirit and an assertive of his determination to fight as ever.  
In an interview, he said:  
"I have confidence that I will be cleared without a great deal of difficulty. I was extradited under the charge of perjury and according to the network existing between the United States and Great Britain I will have to answer to this charge. I am liable only to the charge under which I was extradited. It is alleged that I committed perjury in the answer of the complaint which a woman who claimed to be my wife sued me for alimony. I denied that I had ever been married to this woman.  
"I did not leave San Francisco because I was afraid of being convicted. My wife was in poor health and my netting only made her condition worse. The physician said she must have a change of climate and we went to Canada. Later my wife returned to San Francisco and I am now following her."  
Collins added that he returned to this country of his own volition, because he got tired of fighting the case in British Columbia and was confident of being cleared.

### GERMANY'S NEW TARIFF SCHEDULE MADE PUBLIC

#### WILL BE SUBJECT OF SERIOUS DISCUSSION WITH U. S.

WASHINGTON, Oct. 22.—A statement of the German customs tariffs, comparing the rates of import duty levied in Germany under the old and new customs tariffs respectively, was given out today by the department of commerce and labor. The statement completed expressing the difference between the old and new tariff in ad valorem amounts based upon the German import value of the articles in 1903, the latest year for which figures are available.  
The estimates as to what percentage, ad valorem, the new general and conventional rates will constitute, can only be approximately correct at best. If prices of commodities shall not change greatly, the estimate of what the new ad valorem rates will amount to will be fairly accurate, otherwise they will not. On bacon the rate at present charge is 20 marks per 100 pounds, and highest to be charged under the new general tariff 35 marks, an increase of 80 per cent.  
Among the products constituting the most important items in the export trade of the United States with Germany, the duty that now constitutes the highest ad valorem rate, viz: 35 per cent, is advanced to about 70 per cent ad valorem under the new general tariff, and 43 per cent under the conventional.

The government bill will provide for the construction of the fortifications, but the heavy expense involved.  
The question of the definite status of the Congo Free State will also be considered.  
It is probable that if asked to take final action, both houses of parliament will give substantial majorities to the annexation of the Congo as an integral part of the kingdom of Belgium.

The astronomer announces increased solar activity, with a probability that two new spots, first noted last Friday, will exceed in size any hitherto observed.

### REV. M. J. SAVAGE ATTACKS FEDERATION OF CHURCHES

NEW YORK, Oct. 22.—Rev. Minot J. Savage preached today in the Church of the Messiah on "The Federation of Churches and the Unitarian."  
Dr. Savage prefaced his sermon with: "It seems to me fitting that we should know and help others to know whom the federation of churches is not willing to associate with," and after enumerating the names of many famous men and women who have been adherents of the Unitarian doctrine, concluded:  
"And these men who have been famous in every department of human service and human life are not allowed to be represented in the national conference of the federation of churches. This is not a new move. For four or five years there has existed here in New York city and I think also a state federation of churches, and the Unitarian churches have been cordially welcomed and fellowshiped in all these movements and attempts. I have been asked to contribute money and I have done it every year. A gentleman in Boston, a Unitarian, contributed \$50,000 which was used here in New York to build an Episcopal church. I have no fault to find with that. However, there is enough cordial fellowship and co-operation to go round. It does not seem to me that it is quite fair to have it all one-sided. Is the federation to take the position hereafter that has been occupied by the Young Men's Christian association? What is that? They are persistent beggars, they are ready to take our money at every occasion, get it all if they can, but they never permit us to hold office or have anything whatever to do with their meetings. If we are to stand alone and fight our battles we had better keep our own ammunition in our hands."

They are persistent beggars, they are ready to take our money at every occasion, get it all if they can, but they never permit us to hold office or have anything whatever to do with their meetings. If we are to stand alone and fight our battles we had better keep our own ammunition in our hands."

It is believed that the Texas restrictions will be entirely removed in a short time and that Alabama will also remove all restrictions in a short time. The removal of the Mississippi quarantine is the cause of satisfaction because close relations exist between this city and the coast. There were no new cases or deaths from the fever today. Those places which did report had no new cases.

### MENELIK'S ENVOY ARRIVES

#### Comes to Study Possibilities of Closer Relations With America and Europe

NEW YORK, Oct. 22.—El-Hagg-Abdullah-Ali-Sadik-Pasha, prince of Mohammedan church, general of the Abyssinian army, minister of commerce and envoy of Emperor Menelik to President Roosevelt, arrived here today on the steamer Cedric. He comes ostensibly in regard to the new treaty of commerce between this country and Abyssinia, but absolutely his mission is to study the possibilities of closer relations with Europe and America.  
He has come to America to stay in Berlin, Paris and London.  
Menelik is especially interested in the United States and has already given a home for a legation at Adis-Ababa, the capital, in case this country cares to establish one.  
The pasha speaks no European language and travels with an interpreter.  
On the steamer he wore European costume save for a red fez, but as soon as he reached his hotel here he donned an Oriental costume of wonderful colorings and wore a turban. After two hours of prayer the Abyssinian envoy went for a drive, then returned to the hotel, where he held an informal reception.

### COINERS NOW ON AMERICAN SOIL

#### REACHES PORTLAND ON WAY TO SAN FRANCISCO

Shows That He Has Been Under a  
Terrible Strain, but Asserts  
Confidence He Will Be  
Acquitted

PORTLAND, Ore., Oct. 22.—George D. Collins, who for the past three months has fought extradition from British Columbia to California, where he is wanted to answer to a charge of bigamy, arrived in Portland late tonight in charge of Detectives Thomas Gibson of San Francisco and tonight started on his way to the California city.  
Collins showed glaring evidence of the tremendous strain he has been under since he left the United States and is scarcely a shadow of his former self. He departed from San Francisco a hale, robust man, and returns thin and emaciated, his clothes giving the appearance of garments built for a man much larger than the wearer.  
He still maintains an unbroken spirit and an assertive of his determination to fight as ever.  
In an interview, he said:  
"I have confidence that I will be cleared without a great deal of difficulty. I was extradited under the charge of perjury and according to the network existing between the United States and Great Britain I will have to answer to this charge. I am liable only to the charge under which I was extradited. It is alleged that I committed perjury in the answer of the complaint which a woman who claimed to be my wife sued me for alimony. I denied that I had ever been married to this woman.  
"I did not leave San Francisco because I was afraid of being convicted. My wife was in poor health and my netting only made her condition worse. The physician said she must have a change of climate and we went to Canada. Later my wife returned to San Francisco and I am now following her."  
Collins added that he returned to this country of his own volition, because he got tired of fighting the case in British Columbia and was confident of being cleared.

### GERMANY'S NEW TARIFF SCHEDULE MADE PUBLIC

#### WILL BE SUBJECT OF SERIOUS DISCUSSION WITH U. S.

By Associated Press.  
WASHINGTON, Oct. 22.—A statement of the German customs tariffs, comparing the rates of import duty levied in Germany under the old and new customs tariffs respectively, was given out today by the department of commerce and labor. The statement completed expressing the difference between the old and new tariff in ad valorem amounts based upon the German import value of the articles in 1903, the latest year for which figures are available.  
The estimates as to what percentage, ad valorem, the new general and conventional rates will constitute, can only be approximately correct at best. If prices of commodities shall not change greatly, the estimate of what the new ad valorem rates will amount to will be fairly accurate, otherwise they will not. On bacon the rate at present charge is 20 marks per 100 pounds, and highest to be charged under the new general tariff 35 marks, an increase of 80 per cent.  
Among the products constituting the most important items in the export trade of the United States with Germany, the duty that now constitutes the highest ad valorem rate, viz: 35 per cent, is advanced to about 70 per cent ad valorem under the new general tariff, and 43 per cent under the conventional.

### MONUMENT TO THE POPE

#### Statue Subscribed for by Catholics of the World Unveiled at Riese

ROME, Oct. 22.—A monument to Pope Pius X, subscribed for by Catholics all over the world, was unveiled this morning at Riese, the little village in the Venetian province where the pope was born. The act of administering benediction. The entire village was decorated and national flags were conspicuous everywhere, where the walls were covered with inscriptions, one of which read: "Long live Pope Pius X, the first citizen of the world."  
The authorities formed a procession headed by the patriarch of Venice and six bishops of the neighboring diocese so the house where the pope was born. The eldest sister of the pope and other relatives, who own an inn called "The Two Swords," where they themselves serve the customers, were the recipients of much attention. Many telegrams were sent to his holiness.

### POPE NOT SERIOUSLY ILL

Dr. Lajolo, his physician, authorizes the Associated Press to announce "the statement is incorrect," the pope merely having a cold, so slight that it scarcely could be called an indisposition. Since his last attack of gout in January, his holiness, the doctor said, has enjoyed perfect health.  
Today the pope received over 200 persons. The fact that these audiences have not been suspended is the best evidence of the pope's good health.

#### San Francisco Woman Loses Her Life While Trying to Avoid a Pedestrian

Mrs. Planz was guiding the machine, and while speeding along Van Ness avenue made a quick turn to avoid running down a pedestrian. The auto was upset and the party thrown out.  
Mrs. Planz met death almost instantly and her mother-in-law, Mrs. Henry Planz, was badly hurt. Theodore Planz, the husband of the woman who was killed and his two nieces escaped injury.

### NANSEN IN COPENHAGEN

#### It is Believed He Comes on a Mission Regarding Offer of Norway's Throne
