CITY CHEMIST MILLER SAYS IT'S DANGEROUS Board of Health Prepares to Make It Exceedingly Warm for All Such Violators of City Ordinances

The board of health began its campaign against adulterated foods by the publicity route last evening when City Chemist Miller presented the names of two brands of smoked sliced beef which he declared were being sold in Los Angeles in violation of a city ordinance.

According to Mr. Miller's statement rendered to the board last evening these brands are the White Label and the Magnet, both products being put up by the Armour Packing company of Kansas City.

The chemist claims these products contain a much larger quantity of boric acid than is allowed by the city laws and that neither bears the label declaring them to contain this acid. Under the ordinance the manufacturers may put in a large quantity of this acid if they label their goods plainly so that consumers may know it. The chemist explained the boric acid in the quantities found in these particular brands was detrimental to health if used continually, having the effect of drying up the digestive organs.

The ordinance declares that any dealer who sells products containing ingredients contrary to the city laws is guilty of a misdemeanor and that publication is all that is necessary to make them knowing violators of the laws. The chemist declared yesterday that as soon as the newspapers had had a chance to publish the ingredients of these particular brands he would begin prosecutions against dealers who sell them.

Mayor McAleer advised him to take speedy action.


