STOCK SLUMP CONTINUES

BUSINESS ON WALL STREET IS DEPRESSED

Secretary of Treasury Cortelyou Announces That He Will Make Deposits of Government Money to Aid Crop Movement

By Associated Press. NEW YORK, Aug. 23.—Business "was insignificant at the opening of the stock exchange today. Prices were unchanged or slightly lower. Buying to cover raised Union Pacific to yesterday's closing price and other important stocks rallied half a point.

Dealings were greatly restricted in the afternoon. Prices were about unchanged until 1 o'clock when spasmodic selling caused a sharp depression. Union Pacific fell 2 1/2 below yesterday's price.

Closing was weak at the lowest prices. The bears concentrated their attack against Reading, Union Pacific, Amalgamated, and dislodged considerable stock. Reading and Northwestern fell 4 points. Union Pacific 3. Greenway, Northern preferred and Amalgamated 3/4.

Secretary Cortelyou announced today that beginning next week he will place each week in New York, Boston and such other cities as he sees fit deposits of government funds in sufficient quantities to bring about a steady flow of money in the market during crop moving period.

Secretary Cortelyou plans to prevent panic rather than come to the relief of the market when the market is actually in trouble.

LONDON, Aug. 23.—Supplies of money were easier to obtain in the market today, discounts were easy with brokers taking bills more freely. Americans experienced a steady morning at a fraction over parity. In the afternoon the New York market was heavy for gold and the market closed weak at a fraction above the lowest of the day. Copper shares eased with the price of the metal.

Trading was decidedly light at the call session of the produce exchange Friday, chiefly because the more active wheats were kept at their places by business handling orders for supplies. Friday is generally a good day in the market for dealers, and good volume of trade was registered for Saturday and over Sunday business.

More eastern butter and cheese arrived to go into storage Friday, which products do not appear in the posted receipts. Butter receipts were 1555 pounds, and cheese 1004 pounds. Receipts of potatoes were 1233 sacks.

The only sale recorded on 'change was a lot of yellow covers on light sack. The asked price for cooking butter was 23c, bid 20c; eggs, asked price 29 1/2c, bid 28 1/2c. The market was abundantly supplied with fresh fruit, cantaloupes, grapes and watermelons, and other products.
