STATE ABLE TO HANDLE MARKET CROP

CASH AVAILABLE TO HANDLE SEASON'S FRUIT Report Sent Out from San Francisco

IS TO THE EFFECT THAT WORKERS ARE NEEDED THROUGHOUT THE STATE

SAN FRANCISCO, July 29.—California will be able to finance the handling of the great fruit crop of this season without calling on eastern or European money centers for aid, according to prominent bankers.

Frank B. Anderson, manager of the Bank of California, said today: "California financial interests are amply able to supply the \$41,000,000 or more necessary to handle all the crops of the west, including the salmon pack and also to handle the sugar crop, which will amount to about \$5,000,000 additional. The season will be a profitable one and there seems no danger of any financial hardships this fall."

He recites the fact that two suits have been filed as a result of the alleged non-performance of the agreement, and later, in order to avoid delay, title to the land was conveyed to the trust company, the latter to pay Peck from any sales made sums due him on the first sale of the property. Notwithstanding this agreement, he says, considerable sums have been collected by the securities company, and he also states that the defendants named are insolvent.

One Signature Lacking W. H. Carlson, manager of the securities company, who is named as one of the defendants, said yesterday one of the signatures to the trust agreement had been attached with the exception of one—that of J. H. Strine. He expressed the belief that Strine would sign the agreement, but stated when that is done the trust will become effective. "As soon as this is done," said Carlson, "the trust agreement will be completed and I will be ready to pay over all the money demanded by Mr. Peck."

The defendants named by Peck in the securities company, "John Doe" Longwell, president; C. F. Carlson, vice president; E. R. Smith, secretary; and William H. Carlson, manager of the company. Carlson was in a happy frame of mind last night. He said: "We won the battle. All kinds of

Notwithstanding this agreement, he says, considerable sums have been collected by the securities company, and he also states that the defendants named are insolvent.

One Signature Lacking W. H. Carlson, manager of the securities company, who is named as one of the defendants, said yesterday one of the signatures to the trust agreement had been attached with the exception of one—that of J. H. Strine. He expressed the belief that Strine would sign the agreement, but stated when that is done the trust will become effective. "As soon as this is done," said Carlson, "the trust agreement will be completed and I will be ready to pay over all the money demanded by Mr. Peck."

The defendants named by Peck in the securities company, "John Doe" Longwell, president; C. F. Carlson, vice president; E. R. Smith, secretary; and William H. Carlson, manager of the company. Carlson was in a happy frame of mind last night. He said: "We won the battle. All kinds of
