## NEWS BEGINS SIFTING IN FROM PRECINCTS

### HEADQUARTERS OPPRESSED WITH WORK

Workers' Doling Reported to Democratic Committee and Orders Are Carried Out by Expert Overseers

Democratic headquarters in the Fay building were the busiest spot west of Broadway yesterday.

With most of the central committee on duty there, or making hourly reports, the telephones were ringing all day long.

The character of the reports showed the infinite details that go to make up the closing moments of a campaign.

Precinct 143 sent in word that Republican workers were persistently active within ten feet of the polling places.

In precinct 108, at the rear of 232 East Sixty-fourth street, no workers were on hand to look after Democratic interests.

Dr. A. C. Pratt said he found things in a sorry condition on the west side, as workers were scarce, but the Democrats hung together as best they could.

K. C. Stone of Hollywood came into the committee rooms to report that the Republican clerks in the registration office had registered him in the wrong precinct, thus disfranchising him. He laid the case before the district attorney.

Assembly Candidate Yeakum reported that he found that about 75 per cent of the vote was likely to be polled in the First ward.

Watts telephoned at 3:30 o'clock that two-thirds of the vote had been cast, and that indications pointed to victory for the Democrats.

Huntington Park had a polling place in a store. The Democrats reported that many Taft posters were scattered through this polling place and that protests had been unavailing.

Worker Tibball in precinct 63 reported that Rush and Stephens were running well.

Though precinct 90 at Fifty-sixth and Figueroa streets usually returns Republican majorities indications were that the vote would break even.

In precinct 85 there were twenty-two registered voters who had not declared their party affiliations. There was much Bryan talk there.

Precinct 123, which is usually strongly Republican, apparently had gone Democratic by 3 to 1.

Precinct 133 reported at 3:40 that 215 votes were polled out of a possible 337.

Precinct 128, which is usually Republican, the Democrats remained in the booth about a minute and a half, and the Republicans from three to five minutes. This indicates much scratching.

Worker Earle reported from precinct 18 at 11 o'clock that Democrats needed only eighty-nine more of their registered voters to use up the list of voters.

In precinct 37 by 2 o'clock only four Democrats had failed to avail themselves of the voting privilege. All others registered had cast their ballots.

## MASSOURI CARRIED BY BRYAN AND KERN

### DEMOCRATIC NOMINEE FOR GOVERNOR ELECTED

Friends of Hadley, Head of Republican State Ticket, Refuse to Acknowledge Defeat of Chief Executive

[Special to The Herald.]

ST. LOUIS, Nov. 3.—Up to a late hour tonight the state seems to be carried by Bryan and Kern and by W. S. Cowherd, Democrat, for governor. The latter will have a majority of 5000 to 10,000.

The weather for the most part was clear throughout the state, but the voters did not go to the polls in large numbers in the morning as had been anticipated.

About noon in this city they began to come, and during the hours of the afternoon there was a continuous struggle at many precincts to get into the polling booths.

Bryan is conceded to have carried the state by at least 15,000 plurality and to have run ahead of the state ticket.

In Kansas City, the home of Cowherd, Democratic nominee for governor, there are indications he ran ahead of the ticket, and kept many votes on the ticket which otherwise might have gone to Taft.

In Springfield the Democrats did violent service and carried everything.

In St. Charles county, the voters being largely Germans, some of the precincts showed Republican gains, but these gains were cut down by large pluralities in other sections.

## DEMOCRATIC WORKERS NOT ALWAYS WHERE REQUIRED

### Committee Gets Complaints About In-different Work by Captains, Adjusts Them and Makes Changes Where Possible

Democrats were short of workers during the day in several places where they were needed.

Calls for more watchers were frequent, as well as complaints that some workers were careless.

Precinct 135 had three workers, and headquarters was notified that their presence was unnecessary at that point. These workers were then ordered to report to Major Nolan in precinct 30.

Worker Kennedy, in precinct 29, reported two men there as doing nothing but sitting around. He asked that they be sent home to 519 West Sixth street, so that he could give the idlers something to do.

## NEW TRIALS ARE DENIED TO HYDE AND SCHNEIDER

### Convicted Land Conspirators May Not Be Sentenced Till Motion to Arrest Judgment Is Considered

WASHINGTON, Nov. 3.—Justice Stafford of the supreme court of the District of Columbia today overruled the motions for new trials made by Frederick A. Hyde and Joseph Schneider, convicted last spring of conspiracy to defraud the United States in connection with securing land grants in Oregon and Washington. The motion to arrest judgment was not disposed of, pending which the sentence probably will be deferred. The defendants alleged the jury was coerced into agreeing on the verdict and sought to have the jurors interrogated.

**May Bridge Straits**

VALLEJO, Nov. 3.—During the visit of a delegation from the San Francisco chamber of commerce yesterday an announcement was made of a revival of the project to bridge Carquinez straits from South Vallejo to Vallejo Junction. The business men of this city are advocating a suspension bridge from bluff to bluff, so high as not to offer any obstacle to navigation. It would be erected by the state, according to their plans, and leased to railway companies.
