LAWYERS ALONE IN SCHOOL CASE

PLAINTIFF AND INSTIGATORS FAIL TO APPEAR

TESTIMONY IS FAVORABLE TO DEFENDANTS

Crowd of Witnesses Appears in the Court Room and Examination of All Would Prolong Suit to Next Week

The school bond case crept apologetically into the superior court yesterday, and the trial on the one issue, the question whether or not the secrecy of the ballot was maintained at the January election, was begun before Judge Eldredge of San Bernardino, sitting for Judge Hutton.

The court room resembled a political convention at 10 o'clock, the time set for the trial to begin. Besides the 150 witnesses called by both sides, scores of other persons interested in the betterment of Los Angeles school facilities were present.

Those who testified yesterday were, for the most part, election officers, who stated that while no booths were provided for the marking of ballots, plenty of opportunity was given voters to mark and cast their ballots secretly if they so desired.

Unable to Pick Ballots His testimony was, however, somewhat detracted from when, being asked to point out the affirmative and negative ballots, he confused the slips of paper, indicating the "yes" ballots as the "no" and vice versa.

Says Voters Were Not Influenced On cross-examination by Hartley Shaw, representing the board of supervisors, Mr. Elliott said there was nothing to prevent any person from going to the back of the stable to mark his ballot, and that no effort was made by the election officer to influence the voters, or discover how they voted.

The trial will be resumed at 10 o'clock today. Attorneys representing the defendants in the case are Hartley Shaw for the board of supervisors, Emmett Wilson for the city and Joseph Scott for the board of education.
