

PROMINENT MEN WILL ESPOUSE DE LARA CAUSE

JUDGE JOHN D. WORKS WILL BE ONE OF SPEAKERS

FELLOWSHIP LEADER WILL ACT AS CHAIRMAN

Former City Prosecutor Thomas Lee Woolwine Also May Speak at Simpson Auditorium Mass Meeting This Evening

Judge John D. Works will be one of the principal speakers at the mass meeting to be held tonight in Simpson auditorium, when a protest will be made against the arrest and threatened deportation of L. Gutierrez de Lara, the Mexican Liberal and patriot now in the county jail on a charge of being an alien and an anarchist.

Hundreds Offer Aid
Hundreds of the best citizens of Los Angeles and scores from outlying districts yesterday pledged their defense league, according to statements of the officers of that organization, and the mass meeting tonight promises to be a large one.

Of the seventy-five ministers in and around Los Angeles to whom letters were sent yesterday, asking their presence at the meeting, nearly one-half have signified their intention of attending the meeting, and several of them have announced that they will make the imprisonment of the author-educator-attorney the chief subject of their sermon tomorrow. Members of the local ministry seem to feel that a repetition of the Ferrer horror should not be thrust upon this community.

Ridgeway and Hazen Invited
An invitation has been extended to Immigration Inspector A. C. Ridgeway and to Secret Service Operative George W. Hazen to attend the mass meeting. Chief of Police Dishman has been asked to send a squad of officers to the meeting to prevent any attempts at violence and to arrest any person who seeks to speak without permission from the chairman.

Practical indorsement of the plans of the Defense league was given yesterday afternoon, when an officer of the league went before the Political Equality league and explained the De Lara case to those present at the meeting held in the parlors of the Hayward hotel. The women present were a unit in expressing their belief in the cause and agreed to attend the meeting tonight as a body.

Friend of Countrymen
As many citizens are anxious for information concerning L. Gutierrez de Lara, now under arrest on the charge of being an anarchist, I wish to publish the following, which affords opportunity to know something of this man and his interest in his countrymen.

More than a year ago he called at the Anti-Saloon league office and sought our counsel about how to protect Mexicans from gamblers and saloon sharks at the Arroyo race tracks. On several occasions since then he has conferred with the undersigned about the best way of advancing the interests of Mexicans in this country.

On all these occasions he manifested a genuine and unselfish interest in his countrymen, and in our talk about conditions in Mexico he revealed a clear insight into existing political conditions there, the difficulties to be encountered in any movement to better them and the necessity for a long process of education if success was to be attained.

From what I saw of the man, I cannot believe he is an anarchist. A Socialist he may be, but that is no crime, and I sincerely hope deportation will be prevented, unless the strongest evidence is forthcoming that he is an anarchist, plotting for the overthrow by improper means of rightfully established government.

I write this not as an official of the Anti-Saloon league, but as a citizen interested in justice at home and abroad.

WASHINGTON AUTHORITIES WOULD FIX DE LARA'S BAIL IN SUM OF \$3000

WASHINGTON, Oct. 22.—The department of commerce and labor today telegraphed to Los Angeles, Cal., authority for the release of L. Gutierrez de Lara, who was arrested as an anarchist and an alien who had entered this country without inspection. The whole matter of De Lara's arrest would be simply ridiculous, if it were not that an innocent man's life is at stake if he be railroaded back to Los Angeles, are you ready to sit upon by and allow a man like De Lara—a Ferrer to the Mexican people—to be deported to Mexico, to be shot down by the government authorities?

PROTESTS AGAINST ABETTING LAWLESS TYRANNY OF MEXICO

SAN BERNARDINO, Oct. 22.—Adopting stinging resolutions against the arrest and detention of L. Gutierrez de Lara, the carpenter and anarchist, the authorities and protest against the participation of the United States government in the affair. With other strong statements the protest is embodied in the resolution "That the spectacle of a nation governed by such institutions as the United States, and the spirit of the lawless tyranny of Mexico, is to say the least, a deplorable circumstance that can but merit the condemnation of the civilized world, and that this conduct on the part of our government is inconsistent with the spirit of the universal uprising against the condemnation of legalized murder such as that of which Spain has so recently been found guilty."

CARPENTERS' UNION PROTESTS AGAINST ARREST OF DE LARA

PASADENA, Oct. 22.—Strong resolutions in support of De Lara and against his enemies and those responsible for his incarceration were adopted last night by members of Carpenters' union, No. 769. The resolutions protest against the Russian methods used in effecting the Mexican's arrest, and branding the more despotic than a czar would use.

TERRIFIED AT DARING OF LATHAM WITH AEROPLANE

Crowds Watch Aviator Battle Against Gale Blowing Thirty Miles an Hour
BLACKPOOL, England, Oct. 22.—The capabilities of the aeroplane in the hands of a daring pilot were exemplified here today, when Hubert Latham, the French aviator, gave an exhibition that first entertained and then terrified the spectators. In a monoplane Latham battled against a gale blowing fifty miles an hour, and he twice circled the coast. As the wind came from the north, the gale it appeared at times to stand still in the air. When, however, Latham came about in the wind the monoplane was driven at a rate estimated to be between eighty and one hundred miles an hour.

After years of roaming McFarland settled down in southern West Virginia and began life anew under the name of Press Carter. He married again and reared a family of children, who until yesterday knew not that their father was hanging over his head for the murder of Patton.

WRIGHT SEES BIG FUTURE IN FLIGHT THROUGH AIR

PARIS, Oct. 22.—Orville Wright has outlined his plans on the subject of mechanical flight. "There is not as much danger in flying as there is in automobile racing," he says. "We now turn out motor cars that will run regularly for a short time, forty-nine times out of fifty, and in ten years, or five years, or even two years, I think there will be an aeroplane motor absolutely reliable, and that will be used with our present motor to show what can be done.
