RIPEY DECLARES HARD TIMES ARE AGAIN IN SIGHT

Santa Fe President, Witness in Rate Hearing, Gives Pessimistic View of Future

ADMITS DIVIDENDS ARE BIG

Holds Gloomy Outlook and Increased Expenses as Reasons for Higher Rates

CHICAGO, Aug. 30.—President E. P. Ripley of the Santa Fe, on the witness stand today before Special Examiner Brown of the interstate commerce commission, in support of the contention of the railroads that higher rates are right and just, declared wages paid by railroads have increased largely, making operating expenses a greater burden.

BUSINESS NOT GOOD

"I would not say they are bad; they are not as good as they were a year ago," said Mr. Ripley. "What is the trouble? Have you any idea?"

CHARGES INCREASED

Ripley explained that by increased expenses he referred to improvements, and Mr. Thorne commented:

"So, reduced to its ultimate analysis, you think you are entitled to increased rates in order to build up these facilities, is that correct?"

"In order to keep up with the times and do what the public expects of us," replied Mr. Ripley.

"And make improvements above what you did last year?" asked the cross-examiner.

"Certainly, any railroad that fails to do that is bound for the slide."

Mr. Thorne: "You think that ought to be paid out of the operating expenses?"


Special Examiner Brown shut off questions touching the bond issue for the Kansas City depot by saying:

LAWMAKERS FEAR WORK MINUS PAY

Colorado General Fund Insufficient to Satisfy Demands of Special Session

DENVER, Aug. 30.—Members of the special session of the Colorado legislature in session here discovered today that they stand a good chance of not getting any money for their services unless some future legislature appropriates it.

To remedy this situation the Democratic majority passed a bill appropriating \$20,000 from the supreme court library fund, but could not get the necessary two-thirds majority to make the bill an emergency measure, and the money available as soon as it becomes a law.

WRITE 'W' FOR 'M'; NOMINATION LOST

Democrat on Bourbon Ticket by Error in Initial

Forty-one voters in the recent primaries who wrote "W" where they should have written "M," have deprived M. R. Pendleton, temporarily, at least, of the Democratic nomination for county superintendent of schools.

Mark Keppel, Republican nominee, has been certified as the Democratic nominee, also, as a result of confusion on the part of two score voters as to Pendleton's initials.

The Democratic county central committee will ask a writ of mandamus to compel the supervisors and the county clerk to place the name of M. R. Pendleton on the official ballot as the Democratic nominee.

DENNEEN'S WAR IN ILLINOIS OPENED

Governor Begins Battle Against Coalition Which Tried to Unseat Him

TAYLORSVILLE, Ill., Aug. 30.—Governor Denneen tonight opened the campaign against the return to legislative power of the bi-partisan coalition which dominated the last general assembly. In an address in this city he said:

"The men who opposed the right to honest elections, the right to primary elections, the expressed wish of their party on the United States senatorship, the election of a Republican candidate for speaker of the house of representatives and the organization of the house by a majority of their party are now asking the people, whose will they have defied, and confidence they have betrayed, to entrust them once more with the direction of public affairs. They are running a platform of three planks: 'First—We announce no principles. 'Second—We express no regrets. 'Third—We call for vindication.'"

The governor defined the term "jackpot" which has figured in the Brown trial in Chicago, declaring:

"Those who have been exposed are not the only ones implicated. To make a jackpot effective, however, requires the participation of a considerable number of men as can be held together by the cohesive power of public plunder and an organization able to control, to some degree the course of legislation."

TRIED TO UNSEAT HIM

"This coalition, in its last desperate stand against popular government, deemed it necessary to control the politics of the state in order to prolong its power, and I, whom they had vilified through their spurious investigation of my election, whom they had opposed with vituperative rancor at the primaries, whom they had sought to defeat in the election by arraying against me the special interests from which they derive their strength whose policies they had organized the legislature to defeat, and whom they had attempted to unseat by a trumped up contest, was offered their support for the United States senatorship, an office of high honor when honorably bestowed."

"These efforts to defeat me, unseat me, to promote me, would serve the public purpose. They carry with them their own commendation. When I refused to accept the proffered senatorship the bi-partisan coalition determined to select a senator whose political power would be used to strengthen their position and to make sure of the election of their choice as my successor."

"Such being the situation in our state, what is the next step forward? Manifestly behind the jackpot stans the organization of the general assembly and the control of its business, which the present rules of the house pledge to stand for good government, the next step forward, therefore, is to restore representative government to our house of representatives."

BILLS MUST BE HEARD

"The essential condition of honest legislation must be the right to have bills heard in our general assembly. This is fundamental. Of what avail is it to make a campaign for wholesome measures if they receive no consideration in our legislative body?"

Governor Denneen declared every man seeking support of Republican voters at the September primaries should be pledged to stand for good government, and continued, saying:

"The men who created the unusual and disgraceful conditions in our state should not be given power to prolong them. They have defied instructions and repudiated their party platform; they have stood against representative government and for special privileges and private interests. The extent of their malfeasance in the last general assembly is not yet known, but is under investigation by grand juries and by our courts. The issue in this campaign, then, is: Shall their records, their organization and the results of their work be approved? Upon that issue there should be a difference of opinion among good citizens."

KANSAS RADICALS POUND TARIFF AT G.O.P. CONVENTION

Insurgents, Led by Bristow, Rout Regulars and Manhandle Payne-Aldrich Law

HAIL T. R. AS REAL LEADER

Administration Given a Cold Indorsement, and Progressives Pledged to Continue Fight

(Associated Press) TOPEKA, Kas., Aug. 30.—With the insurgent faction of the Republican party of Kansas in complete control, the state party council today adopted a platform decidedly progressive.

Governor Stubbs was elected chairman. Later he resigned and Senator Bristow was chosen to preside over the council during the rest of its session.

When Senator Bristow took the chair he spoke on party issues. He upheld the inheritance tax, condemned monopolistic control and declared more legislation should be enacted regulating the railroads.

"The Payne-Aldrich tariff bill enacted by the congress of 1909 did not follow the standard fixed in the national platform for the protection of our agriculture of its pledges. I believe a new tariff measure should be passed, and mean to fight for it just as long as I am in the senate."

"Moreover, I believe we should be allowed to vote upon every section of a tariff bill separately. Senator Bristow declared in favor of the Oregon plan of electing United States senators and for a graduated income tax.

The committee on resolutions submitted its report and the platform was adopted without change.

PLATFORM IS INSURGENT

It was prepared by William Allen White, the Emporia editor, and embodying the sentiments as expressed by Senator Bristow, Gov. W. R. Stubbs, Congressman Victor M. Murrain and the other insurgents, and was as follows:

"We, the Republicans of Kansas, in party council, desiring to express our pride in the achievements of our party, that respect and veneration to those traditions and for the history we have made that may be most adequately and fittingly expressed by turning our faces forward rather than backward. Therefore we bind ourselves to specific future performances rather than to ask for votes by reason of our past achievements, however great it is. Our platform shall be a guarantee of performance rather than a confession of faith."

"Yet we must congratulate President Taft as Republicans upon the successful outcome of the progressive party measures in congress; the postal savings bank law, the railway law and the law providing for the publicity of campaign expenses; and in this connection we wish to commend Representatives Murdock and Madison for their work in congress pursuing the instruction of the Kansas Republican platform of 1908; in modifying the rules of congress, so that the enactment of these long delayed measures was made possible. We pledge our support to Senator Bristow for his hard and efficient work to carry out successfully his platform pledge to secure the enactment of the well known long and short haul clause in the interstate commerce law."

DEMAND TARIFF REVISION

"We pledge our loyalty to the Republican national platform of 1908 and bind ourselves to carry out its declarations, accepting the policy of protection and the tariff reform of the platform as the established policy of the nation and binding our members of congress in both houses to vote steadfastly and without reserve on any other instructions, for a revision of the tariff law of 1909, using as a basis for fixing duties the difference between the cost of production at home and abroad and the reasonable profit for American manufacturers."

"We do not recognize the revision of the tariff of 1909 as a satisfactory fulfillment of the tariff pledge of the Republican platform. And we therefore pledge the people of Kansas that the Republican senators and congressmen from this state shall work for a revision of the tariff law, creating an independent non-partisan tariff commission with ample power and sufficient appropriation to ascertain accurately the physical valuation of the raw materials of production at home and abroad, and after having obtained such information we hereby pledge our Republican senators and representatives to work for a revision of the duties upon the basis of this information."

"We pledge our senators and representatives to vote for a joint resolution that will promote the revision of the tariff, one schedule at a time."

HIT AT CANNONISM

"We pledge our Republican members of the lower house of congress to support and vote for a rule that will make the members of the more important house committees elective instead of appointive."

"We demand the strictest enforcement of the anti-trust laws and pledge our Kansas Republican congressional delegation to vote for a law providing for a jail sentence for willful violators of the anti-trust laws."

"While endorsing the amendments made to the interstate commerce law by the last session of congress we pledge our senators and representatives to vote for such further amendments to the interstate commerce law as will give power and money to the interstate commerce commission to ascertain the physical valuation of the raw materials of production of the railroads."

"We pledge our Kansas Republican congressmen to work and vote for effective laws that will prevent over-capitalization of the railroads, and will vest all moneys received for the sale of stocks and bonds to actual investments in construction or extension or betterment of property owned by the railroads."

"And we further pledge our Republican congressional delegation to work for laws that will give the interstate commerce commission authority over corporations."
