Terrible Affair—A Woman Jumps from a Fourth Story Window of a Hotel and is Killed.

We learn from the Buffalo Republican that on Thursday night, about 11 o'clock, Mrs. J. C. Batten, a lady residing in the Union Hotel, committed suicide by jumping from the fourth story window. An inquest was held, and the testimony all went to show that the act was committed while the woman was in intoxication. The clerk testified that during the day he sent up to her three quarts and a pint of beer, and one glass of brandy. Isaac Miller, of Chautauque county, testified: I slept in the next room to Mrs. Batten's room; a light shone through a window over the door, of which window two panes of glass were broken. I heard talking during the evening; I could hear every word that was said; I heard her abusing Mr. Patten for some time, declaring that he should not come near her bed; that she wished she had strength of a man she would spill his heart's blood; did not hear him say a word; after a long time, I could not get to sleep in consequence of her noise, and I asked if she would not be quiet; she said she wouldn't, and raved round considerably; after a while she opened the window, when he got up and shut it; she opened it again and he shut it; again, she opened it a third time, and in a few moments afterwards I heard a scream, he jumped out of bed and exclaimed, My God, she's gone! he then ran to the stairs. When found, she was breathing very heavily, and her skull was fractured. She died in a few moments after being carried into the house.

He claims that not a dollar of the money of the State has been used illegally, or misapplied by him, but that the chances are that the three hundred and three thousand dollars obtained from Breslin by him, would not otherwise have been brought into the coffers of the State. By his exertions he claims that fifty thousand dollars was secured of Breslin's suspended debt, from Dayton Bank, of the Beekel claim, part of which has been paid. That Mr. Breslin would have, if then exposed, left immediately for Canada, and that he relied upon his personal influence with Breslin, and confided on his promises, and carried the load he did until it crushed him. Testimony will show Mr. Breslin's complicity with Maryland and Indiana banks, with railroad investments, &c., at home, the pressure on him to use the public money for party purposes by urgent leaders, &c. One of the Hamilton county parties, really or ostensibly, as it is very well known, lost at a gambling table during or about the time of the assembling of the National Democratic Convention at Cincinnati, a sum of money reported to be \$47,000; suit for which was entered, but a large portion was paid on the withdrawal of the suit. It has been reported that gamblers followed the same party to Kanawha, where over fifty thousand dollars more were lightened from his pockets, much of the money being of the far-famed bank in Maryland, in which Breslin exploited, and to retain the charter for which recent testimony says \$10,000 was expended by Breslin. Was that for lobbying in the Maryland Legislature?

PRECISE AMOUNT OF THE DEFALCATION. GIBSON'S TESTIMONY. BRESLIN IN WINDSOR, CANADA. HIS PRECAUTIONS AGAINST ARREST. GIBSON'S APOLOGY. WHERE THE MONEY WENT.

How Much was Wasted at the Cincinnati Convention and at Senator Pugh's Election. COLUMBUS, O., August 1. The Treasury Investigating Committee having but limited powers—unfortunately not those of sending for persons and papers, expect employees of the Treasury office, and the Depositories of the State, the examination proceeds slowly. Report will not be made, perhaps, for ten days. Mr. Breslin has covered up his tracks so that it will be difficult to trace whereabouts is the people's money. Mr. Thomas Sparrow, well known as a leading member of the Democratic party of Franklin county, recently Post Master of Columbus, and member of the Investigating Committee which examined the Treasury in 1847, is a lawyer of industry and ability, and is devoted to a thorough search, as far as is in the power of the Committee, of the complicated details of official mismanagement and mystification of the two late Treasurers. A thorough overhauling of the Auditor's and Treasurer's books has been made, and a statement of the account of the Treasury from January 12th, 1852, to June 13th, 1857, has been prepared, showing that the defalcation at the latter date amounted to \$728,691.01. The Committee have devoted the investigation to those two points.—How much has been the defalcation? By whom has been the default? I assure the people they have worked with an industry and ability which is to their credit. I believe they are satisfied, that they have determined the amount wrongfully withheld from the State, to be the sum noted above. To decide the question, by whom has been the default, I learn that extensive testimony has been taken. A number of parties have been questioned as to the business relations of both the Treasurers implicated, and after a close examination of Mr. Gibson's, whose testimony is comprised in 40 MSS pages, with all papers and accounts in their reach, Mr. Gibson's former statements to the contrary, only \$333,000 have been returned of a sum of more than one million dollars, taken from the Treasury by Mr. Breslin, of which he alone was in default, making John G. Breslin a defaulter for \$728,691.01. Of this sum he furnished depreciated paper amounting to \$154,636.36, making the State a loser outright and unaccounted for of \$574,054.65. Mr. Gibson claims that not one dollar of the public money has been put into his hands or been lost by him and presents an account of a balance due to him by the State of \$16,000. The developments of the committee will show up some gentlemen who have affected to be very indignant at the official conduct in this transaction of the present Executive. At the time Mr. Breslin was making his annual statements, in October, 1850, which showed that over \$700,000 was then in the Treasury, it will appear from the testimony of Mr. Beahler, Cashier of the Clinton Bank of this city, that Mr. Breslin's draft for \$50,000 was protested in New York, and not paid for weeks after its return here, and then in dribbles, which facts were known to the Fund Commissioners and Governor Medill. Mr. Auditor Morgan, whose books called for the Treasurer to have on hand the large sum of money reported, knew of this dragging the honor of the State in the dust, and no Governor then called on the defaulting Treasurer to resign as did Governor Chase when Mr. Gibson's revelations were made known to him. Mr. Breslin lost the confidence of his own political friends here, when he left his own country and fled to the dominions of Queen Vic—the refuge of fugitive slaves. Testimony has been given that he has signified his intention not to return, and a few days since his family repaired to Windsor, his present place of sojourn. One of my former articles spoke of the possibility of a celebrated Cincinnati Police officer being able to secure the return of Mr. B. Forewarned, the gentleman in Canada I asked himself with deadly weapons, prepared to defend himself from illegal arrest, being satisfied no treaty stipulations warranted his extradition. Mr. Gibson, under \$110,000 bonds for his appearance at the Franklin county Court in October, has been here for several days and returns this morning to Tiffin. He declares that no human soul was knowing of the fatal step taken by him of concealing Breslin's defalcation. His motives, he declares, were two-fold. To protect his own interests, and those of the State. He was personally liable on his bond for \$250,000, his dearest friends in Seneca county, many of them induced to become so by him, were also Breslin's securities. On learning of his predecessor's defalcation, he deemed it to his and their interest to save him and them from loss. For the interest of the State, he deemed it best to conceal it and obtain as much of the money back as he could, by carrying the load on his shoulders fatal determination.
