

# THE CHINESE FIRE CLAIMS

## Number Filed With the Consul is 2573.

### VIGILANCE HAS BEEN NECESSARY

#### All Sources Have Contributed to Information of the Chinese Consul General.

Yang Wei Pin, the Chinese Consul, has almost concluded his work of investigating the fire claims of the different Chinese residents of this city who were sufferers in the disaster of a little more than a year ago. The total number of claims that have been filed with him are 2,573. Of this number he has, in turn, filed, roughly speaking, something like 2,400 with the commissioners. The 2,400 claims represent something like \$400,000 worth of property. The 173 documents that are yet to be placed with the commissioners stand for a valuation of \$50,000. Those that are yet to come are the demands of the heaviest losers in the fire of last year. The summarizations that have been placed before the commissioners heretofore have been those of small merchants and Chinese in the lumber walks of life. The work has consumed two or three months of the Consul's time and he is glad that the tiresome duties that have been demanded of him and his clerical force, of going into the particulars of the personal effects of cooks and plantation laborers is at an end.

Just exactly what has been lost by the different sufferers will never be known definitely, of course. Much of the information has been gained through the Custom house. Again, when a man's residence was known, it naturally followed that he lost something. If the house was destroyed, the man's position in life, and the locality in which he had made his residence were the next things that were drawn upon in forming an opinion. For example, when a plantation laborer credited himself with having lost a gold watch, the item was stricken out without further consideration, unless the Chinaman could prove beyond all question that he had been possessed of the property as claimed. When a cook claimed to have been dispossessed of costly silken robes, his assumption was passed without notice. The work, which has been conducted in person by the representative of the Chinese empire, has required some keen detective work. When proofs that would have passed without being questioned, under ordinary circumstances, were submitted, the vigilant officer of the Empress Dowager has set about to prove the authenticity of many of these in turn.

The final disposition of the claims rests in the majority of cases between the Consul and the court itself. The power of attorney has in many instances been given to him, and the last appeal, from whose opinion there is no hope, rests with the commissioners themselves. Just when the entire 2,573 cases will be disposed of is hard to say. In the two months that have passed there have been something in the neighborhood of twenty claims closed. In addition to those of the Chinese Consul, the Japanese Consul has several thousand, and there are a number of whites who are also sufferers whose allegations must be passed upon.

Consul Yang Wei Pin has been so hard at work for the past two months that he has been overcome by the strain and is suffering a slight illness. He hopes to be at work once more by the middle of the week, if his physical condition continues to improve.

### HAWAII DRY AND DUSTY

Marston Campbell Found it a Long Time Between Baths.

Marston Campbell was a passenger on the Mauna Loa Friday. He returned rather unexpectedly, catching the steamer by the merest chance. He had been away from Honolulu for a fortnight, up to the time of his return, examining the roads on the mokuapuni nui, which he reports to be in excellent condition, considering the lack of funds at the disposal of the roadmakers of the Big Island. Everywhere he found the thoroughfares dry and dusty. The lack of rain has affected everything on Hawaii. Vegetation of all kinds is dying, and water has become possessed of a commercial value. It costs twenty-five cents a bucket for water with which to quench the thirst of the horses belonging to the travelers who are going over the Island. One day after Mr. Campbell had driven from sunrise to sunset, followed by a cloud of white, blinding and stifling dust, he came upon a little Chinese store by the roadside and asked the woman at the door for water with which to wash. She shook her head in his inquiry, and said: "No water for wash. Water only for tea now." No amount of entreaty could change her mind.

As soon as the Legislature has taken its final action in the matter of the Appropriation bill and the Governor has signed the same, there will be more work done on the roads of Hawaii. For the present the roads are receiving no more attention than is necessary to keep them passable. Mr. Campbell found the trip a very

trying one and does not care to go through the experiences of the past two weeks for some time to come.

### NATIVES KILL A JAPANESE

Further particulars concerning the murder of Yoshita, a Japanese employed on the Naalehu plantation in Kau, have been received. The dead man's body was found under a flume near the mill the morning after the murder was done. Three natives have been arrested. One man, it is believed, committed the deed; the other two were accessories to the fact.

The murdered man, Yoshita, was employed by Henry Martin, the road builder of the Naalehu plantation. On Monday, July 1, he was sent to the office of the sugar company to draw some money, and the natives, learning of the fact, lay in wait for him and assaulted him upon his return. It was after the set of sun when the Japanese started for Mr. Martin's place. Near the mill he was attacked by the three men, Sam Kaluna, Lepeka and Piliho. It is thought that he was choked and beaten to death, judging from the condition of the body.

Kaluna is supposed to be the man who committed the foul crime. The other two are implicated to a greater or lesser extent, but how much is not known.

The letter below has been received by Henry Smith, clerk of the courts: Henry Smith, Esq., Honolulu.

Dear Sir: A very horrible murder has been committed at Naalehu on the night of the 1st by which one Yuchida, a male Japanese, lost his life. The persons who committed the murder are now lodged in jail. They are all Hawaiians, two men and two women. The affair arose through gambling and drunkenness. J. H.
