

THE COACH'S DREAM OF AN IDEAL FOOTBALL PLAYER.

5--MAILES BEST HONOLULUS--0

It was a battle of the giants at baseball park yesterday afternoon when the pride of the Honolulu Athletic Club went down to defeat before the Maile Illma team by the heartbreaking score of 5 to 0. Lovers of football went out expecting to see a good game and in this they were not disappointed. For fifty minutes of hard, grueling work the two teams swayed back and forth on the white lined field and although success was with the Mailes from the first there was never a moment when one could be absolutely sure of the outcome.

Football is essentially a college sport and needs the regular training that college men can give it and the college enthusiasm to lend it color. These, of course, were lacking yesterday but it is doubtful if two club teams, composed of busy men who have little time for practice could put up a better exhibition of football than did the Mailes and Honolulu yesterday.

Team work won for the Mailes. Coach Benson has succeeded in instilling in the minds of his men that cardinal principle of football—"Eleven men in every play." Venhuizen, the old Pomona College star and his supporters, Plunkett and Heilbron in the back field were in every play and did star work. Captain "Ben" Clark at quarter, ran his team without a fault, but it was not these individuals, it was the team as a unit that won the day.

The Honolulu were game losers. They had many stellar players. Ensue whose magnificent 43-yard run, was the sensation of the day and whose tackling was above par, Blaisdell, who ran his team faultlessly, the line men who do most of the work and get the least of the glory, and the backs who played hard and consistent football are all worthy of mention yet as a team the H. A. C. failed signally to pull together in critical moments. Coach Woods who got into the game in the middle of the second half injected life into his men and played a snappy game against big odds. His work at quarter was excellent.

It is to be regretted that there was so little open work, end running, kicking and quarter back running. In spite of the new rules, the old savage line pounding seems still the prevailing style of play.

The game was clean and the officials gave general satisfaction. What little kicking was done was in good spirit and the decisions were accepted without dispute.

The Mailes are unbeaten as yet and have an excellent show for the cham-

ionship although the Punahou are in the ascendancy and the H. A. C. may have an end-of-the-season rally.

GAME IN DETAIL.

FIRST HALF.

The Mailes won the toss and took the kickoff, the H. A. C. defending the mauka goal. At 3:03 Eugene Allen kicked off 31 yards to Blaisdell, who ran in 10. Kanae bucked left tackle for 3½ and followed with 3 through the same hole. Dawes went straight through for 2 yards and Sullivan made 2 more on a cross buck. Blaisdell kicked 30 yards out of bounds. Maile ball. Plunkett plunged straight through for 2 yards. Allen found left guard for 4½ and Heilbron broke through for 4½ more. Allen followed this with 5 yards through right guard. Heilbron went straight for 1½. Allen through left guard for 3 and it was third down. Allen made distance with 2 yards through left guard. On the next play Plunkett got away around the end for 9 yards. Allen made half a yard through right tackle and followed with 6 more through the left side. Ellis is substituted for Lightfoot.

Plunkett plunged through the line for 4 yards and Allen made it first down with 1½ through left guard. He followed with 2 through the same place. Plunkett smashed through for 2½ and Allen found left guard good for only 2 feet. Time was taken out by H. A. C. Plunkett went through tackle for 4½ and Allen through right guard for 2. Heilbron hurdled for 1 yard. Allen tried left guard for 2 yards. It was third down and Plunkett was stopped in his tracks and the H. A. C. took the ball. Blaisdell punted out of danger 15 yards to Clark, who ran in 4. Heilbron ran left end for 4½ yards and Allen made half a yard by hurdling. Heilbron hurdled for 1½ and Clark failed to get the ball to him on the next play. Modlin fell on it. H. A. C. ball. Sullivan tried left end for a loss and Blaisdell punted 28 yards to Clark, who fumbled, but recovered. Maile ball. Coulter received a bad pass and lost a yard on a tackle around play. Plunkett tried right end for no gain and Freeth kicked 20 yards to Dawes. H. A. C. ball.

Kanae made 4½ through left tackle. Sullivan 3 on a cross buck and H. A. C. was penalized 15 yards for Kanae's holding. With second down and 20 yards to gain Blaisdell kicked 35 yards to Clark. Maile ball. Plunkett goes through right end for 3 yards and Allen tries right guard for half yard. Time out for H. A. C. Venhuizen takes Allen's place as full for Mailes and bucks left guard for 3 yards. Heilbron makes 8 yards around left end and Mailes are penalized 15 yards for using

hands and arms. Plunkett is tackled by Ensue for a 5 yard loss and Freeth kicks 40 yards to Blaisdell, who runs in 23, going out of bounds. Sullivan makes a foot on a cross buck and H. A. C. takes time out for Kanae and others. Sullivan bucks straight for 5 yards and again for 1, while Dawes tries a cross buck for no gain. Blaisdell kicks 30 yards to Clark, who is downed in his tracks. Maile ball. Venhuizen hits right guard for 1 yard. Heilbron dashes around end for 3½ and Venhuizen goes through left for 2. Plunkett makes a short end run for 4 yards and Heilbron makes only 2 feet on a straight buck. With four minutes to play Venhuizen penetrates left tackle for 2 yards and Plunkett gets away around right end for the first long run of the game, being tackled by Ensue after covering 25 yards. Heilbron goes across for 4 yards. Venhuizen through left guard for 1½ and Heilbron again gets away around the end for 9 yards. Time out for Gleason. Venhuizen bucks right guard for 8 yards and again for 4 yards. Freeth falls in an attempt to kick a drop field goal from the 32 yard line just as the whistle blows for the first half.

SECOND HALF.

The second half opened with McDuffie in Houghtaling's place for H. A. C. At 3:47 Blaisdell kicked off 30 yards to Heilbron, who ran in 20. He followed with 5 yards around left end and Venhuizen found right guard good for 5½. Heilbron tried the line for 2 and Venhuizen went through the right side for 2½. Plunkett went through the line for 3½ and Heilbron made 4 around the end and hurdled for 2½. Venhuizen went through right guard for 2 yards. Renear was substituted for Sullivan. Venhuizen hit right guard for 4 yards. Heilbron left end for 4½ and Venhuizen right guard for 3. Plunkett hit the line for 6 yards and Heilbron for 1½, followed by 3½ around the end. Venhuizen went through the right side for 3½. Heilbron dodged around left end for 8 yards and on the next play carried the ball over the line 7 minutes after the half opened. Freeth failed to kick the goal. Score Mailes 5, H. A. C. 0.

Freeth kicked 45 yards to Kanae, who ran in 20 and fumbled, but Dawes fell on the ball. Renear hit the line for 2 yards and tried a cross buck for 1 yard. Blaisdell could not find any one to take the ball and ran out of bounds with a loss of 6 yards. Blaisdell kicked 35 yards to Clark, who ran in 8. Venhuizen tried left tackle for 4 yards and Heilbron stampered through the same place for 10 more. Jarrett tried a tackle run for a half yard. Venhuizen only made a half yard through right tackle. Time was taken out for Dawes. Venhuizen could not gain and H. A. C. took the ball. Ensue ran 43 yards around right end and took out. Woods took Blaisdell's place and Blaisdell went in for Dawes, while Dawes retired from the game. With only 15 yards to go the H. A. C. took a brace and started

for a touch down. Renear tried the line twice for 2 yard gains and Blaisdell took out time. Kanae hit the line for a yard and Blaisdell left end for 2. Kanae made 2 and Renear failed to gain. This ended H. A. C.'s show for scoring.

Heilbron hit the line for 2 yards and Venhuizen for 3. Plunkett fumbled, but recovered, making 1 yard. Heilbron could not gain and Freeth kicked 25 yards. Blaisdell ran in 10. Ensue was tackled by Venhuizen for no gain. Kanae made 4 through left guard and Renear was stopped in his tracks. Maile ball. Heilbron went through left tackle for 3½ yards, being stopped by Woods. Time out for Heilbron. Venhuizen broke through right guard for 8 yards. Jarrett went around for 8 and Venhuizen again went through for 3. Plunkett broke through the right side for 10 yards and left for 5½ and again across for 4½. Clark recovers Jarrett's fumble for a half yard loss and Plunkett shoots across for 3 yards. Heilbron is thrown back for 3 yards on an end run and Plunkett stampered through right tackle for 6 yards. Venhuizen took left guard good for 2½ yards and the Mailes take out time. With three minutes to play Plunkett crosses for 4½. Venhuizen bucks right for 2½ and Heilbron goes straight for 1. Plunkett goes across for 2. Venhuizen hits right guard for 3 and Heilbron for 1½. Heilbron fails to gain and time is called at 4:24, with the ball in the possession of the Mailes on the H. A. C. 20 yard line.

JOCKEY CLUB FOR THE BIG ISLAND

HILO, Hawaii, Dec. 8.—The island of Hawaii is to have a jockey club such as are organized on Oahu and Maui. At the preliminary meeting of the subscribers to the stock of the proposed jockey club there was a large and enthusiastic attendance. The sum of \$3240 has already been subscribed and the meeting last night in Firemen's Hall was for the purpose of organization. John T. Moir and J. D. Easton were elected temporary chairman and secretary and a committee consisting of W. H. C. Campbell, Albert Horner and Dr. Irwin were appointed to draft by-laws of the Hawaii Jockey Club.

The Volcano stables tendered the club the use of Hoolulu park for the New Year's races, and by unanimous vote the offer was accepted and a committee on arrangements consisting of W. H. C. Campbell, F. Brughell, R. A. Lyman, C. E. Wright and J. D. Easton were appointed, who will have entire charge of the affair. Subsequently this committee met and arranged an attractive program for the proposed race meet.

The program as outlined thus far will include the following events:

- First race—One-half mile dash, \$100 prize.
- Second race—Named harness race (best two in three), one-half mile heats, owners driving; entries, Sydney, Dr. M. Rice, Harry, C. E. Wright, \$25 prize.
- Third race—Three-quarter mile dash (free for all) \$125 prize.
- Fourth race—Pony race, 14 hands and under, \$25 prize.
- Fifth race—One-half mile, Hawaiian bred, \$75 prize.
- Sixth race—One mile (free for all) \$150 prize.
- Seventh race—Japanese sweepstakes race, one-half mile, horses to be ridden by Japanese only, sweepstakes.


LUAU AT PENINSULA TO FOOTBALL TEAM
