entered the room. Quiet and absolute freedom from excitement are considered essential.

Mrs. McKinley has not seen him today. She was in the sick room last night after the President had recovered from the effects of the anesthetic. She displayed wonderful pluck and nerve and is bearing up bravely. It is probable she will see the President later in the day.

SYRACUSE, N. Y., Sept. 7.—Vice President Roosevelt left here at 10:20 a. m. en route to Buffalo. His car was guarded by detectives and was locked. Cards of intimate friends were refused.

11:30 a. m.—The prisoner, Czolgoz, has been taken down to the office of Superintendent of Police Bull for examination in private.

HE TRUSTED THE PEOPLE.

President Would Not Heed Attorney-General Griggs' Warnings.

NEW YORK, Sept. 6.—Former Attorney-General Griggs in discussing at Paterson, N. J., the shooting of President McKinley, said: "I warned him against this very thing time and time again. I asked him for the country's sake and his own to have a bodyguard when he went out. He refused. He laughed at me. He insisted that the American people were too intelligent and too loyal to their country to do any harm to their Chief Executive. He had supreme confidence in the people."

AVERSE TO BODYGUARD.

President Disliked Restrictions Upon His Movements.

WASHINGTON, Sept. 7.—President McKinley was averse to a bodyguard or to restrictions on his movements, and was exceedingly informal and democratic while in this city. On many pleasant mornings he indulged in a half hour's stroll entirely alone through the southern portion of the grounds surrounding the White House.

Very often he left the gate at the western side of the grounds and was joined by Comptroller of the Currency Charles Daves, also an early riser, and together these two men would make the circuit of the Ellipse, south of the White House grounds. Upon these occasions he was never accompanied by a body guard or a secret service man. It is said Mr. McKinley was often warned that the strolls alone were dangerous, the idea of which he ridiculed.

Frequently Mr. McKinley drove about the city and its suburbs. Often the President himself handled the reins, but at no time was there ever a secret service man in attendance either near or at a distance. The closest attendant in the secret service force that the president had was George Foster, who constituted his personal body guard. A few days ago a Washington Post

reporter, while at Buffalo, talked with Captain Valleley of the exposition force on the precautions he would take to insure the president's safety. Captain Valleley said he had picked men of the country under him, and that all the time the president was in the exposition grounds he would be surrounded by alert detectives who would form a constant body guard, and ridiculed the possibility of danger.

THE VICE-PRESIDENT EXCLAIMED "MY GOD!"

Leaves Burlington, Vt., As Soon As Possible For Buffalo.

BURLINGTON, (Vt.), Sept. 6.—The first news of the attempted assassination of the President reached Vice-President Roosevelt at Isle la Motte, at 5:30 o'clock this afternoon, when the Vice-President was informed over the telephone that there was a rumor that the President had been shot. It was confirmed by another message a moment later. The Vice President seemed stunned by the news, put his hands to his head and exclaimed: "My God!" Those around him were immediately informed of the tragedy, and it was decided to announce it to the company of a thousand people who had gathered to hear Col. Roosevelt speak at the annual outing of the Vermont Fish and Game League.

Senator Proctor made the announcement, and many persons in the audience burst into tears. The Vice President then left immediately and came to this city as quickly as possible, having directed that all messages should be held for him here. President Cleveland of the Rutland Railroad placed a special train at the disposal of the Vice President and made arrangements to take him on it to the scene of the tragedy. Col. Roosevelt was asked at the wharf for a statement for publication, and said: "I am so inexpressibly grieved, shocked and horrified that I can say nothing."

He boarded the train and left for Buffalo.

Ex-President Cleveland Shocked.

WINSTED, Ct., Sept. 6.—Ex-President Cleveland was fishing at Darling Lake when he received the news regarding the shooting of President McKinley. He immediately started for the shore, in order to hear the details, and anxiously asked for the latest news from the President's bedside. Mr. Cleveland was horrified at the news, and said: "With all American citizens, I am greatly shocked at this news. I am not conceivably a motive. It must have been the act of a crazy man."

GOVERNOR DOLE REGRETS SHOOTING OF PRESIDENT.

Governor Dole was awakened at his home early this morning and informed of the tragedy. "Oh, it is terrible, terrible," exclaimed Mr. Dole. "I regret it so much. Although I can

hardly realize the truth of it all, I feel that an immense misfortune has befallen the nation."

Mr. Dole was asked that if in the event the Ventura brought news this morning of the death of the President, the Territorial offices would be closed today. He replied that they would, and intimated that extensive cognizance would be taken of the matter by the Territory in case of the expected unhappy outcome.

SECRETARY COOPER ARRESTED FOR ALLEGED EMBEZZLEMENT

Released on \$1000 Bail, Pending Further Action of Circuit Judge Gear This Morning.

Henry E. Cooper, Secretary of the Territory, was arrested last night at about 10:30 o'clock on a warrant charging him with embezzlement, the same being sworn out by Ung Sung, the Chinese who claims that his naturalization papers as a citizen of the Republic of Hawaii are unlawfully withheld in the office of Mr. Cooper, and it was for the alleged wrongful withholding of these papers that the charge of embezzlement was made.

The warrant was issued about 5 o'clock yesterday afternoon by Judge Gear, on application of Andrews, Peters & Andrade, representing the Chinese, Ung Sung, and service was made on Mr. Cooper at 10:30. Mr. Cooper was taken to the Police Station, and Judge Stanley, as his attorney, made arrangements for bail, the bond being in the sum of \$1000 and returnable at 10 o'clock this morning. Sometime elapsed before Judge Gear could be found, and Mr. Cooper remained in the custody of the High Sheriff until about 11:30 when Judge Gear approved the bond and Mr. Cooper was released.

Later the original warrant of arrest was revoked by Judge Gear. Secretary Cooper was intending to leave today's Sierra, and it is understood that arrangements will be made this morning before the sailing of the steamer at 10 o'clock, through which he will be permitted to go to the Coast in accordance with his original plans.

Secretary Cooper's arrest last night was the outcome of a contention which began some time ago. Ung Sung was charged by Mr. Cooper with false impersonation, and was arrested on a charge of impersonating Yee Wo. The whole trouble was due to the fact that Sung has two names. He admits that he does business under the name of Yee Wo, while his real name is Ung Sung. When Ung Sung wanted his naturalization papers for the purpose of presenting them at the internal revenue office at the time of the registration of Chinese, Cooper thought he was trying to impersonate Yee Wo. Sung now wants his papers as a citizen of the Republic of Hawaii, and a few days ago instituted the suit in replevin for their recovery. The warrant sworn out yesterday afternoon represented another method of obtaining the papers which Ung Sung is testing.

CAPTAIN CLUNEY INJURED THROUGH RECKLESSNESS

Is Knocked Down on King Street by Horse Driven by Japanese Hackman Yesterday Afternoon.

Knocked down by a recklessly speeding horse, driven by a Japanese, Nakan, and attached to hack No. 52, which was turning from Bethel street into King street, going in the direction of Waikiki, yesterday afternoon, Captain Cluney, a man almost seventy years of age now lies in bed at his home, suffering from various and sundry minor bruises and a severe shaking up, thinking no pleasant things of reckless Asiatic hack drivers.

Captain Cluney, about 3 o'clock yesterday afternoon, was crossing King street, towards the southeast corner of Bethel street with a number of packages in his arms, when hack No. 52 came swiftly round the corner, the horse knocking the old gentleman down. Driver Nakan continued on along King street until he was stopped and arrested.

J. H. Black, a friend of Captain Cluney, was standing near at the time of the accident, although he was not aware of what had occurred until Captain Cluney was lying unconscious on the road. Black and others hastened to the assistance of the captain, and he was put into a hack and taken to Dr. Herbert's office. He was bleeding from wounds on his arms and hands and head. Dr. Herbert found that the thumb of the captain's left hand had been broken, that an artery over the left eye had been cut and that various minor bruises had been inflicted.
