WOODMEN INDIGNANT

Hamilton County Woodmen Denounce Davenport Dispatch as Fiction

HEAD OFFICERS MAY BE GUILTY

The Chief Officials of Head Camp, M. W. A., in Rock Island, Illinois, Known to Be Working for Readjustment and Are Suspected of Sending Out False Report to Further Their Interests.

Webster City, April 18.—Hamilton county Woodmen are surprised and highly indignant at certain dispatches sent out under a Davenport dateline the other day to the effect that the National camp of M. W. A., to meet at Indianapolis in June, will adopt the proposed plan of readjustment. Hamilton county lodges are all vehemently opposed to the plan and have every possible assurance from camps in Illinois, Michigan, Wisconsin, Minnesota, Iowa, Kansas and Nebraska, that these states are practically united in opposition to the plan.

Officials high in standing in the local camp do not mince words in denouncing the Davenport dispatch as mere fiction. Several of them even go so far as to state it is their belief that this dispatch was written in the offices of the head camp in Rock Island, Illinois, by the head officers, who are fathering the readjustment scheme, and send across the river to some Davenport correspondent or reporter who seized upon it as "good copy" and sent it out. This report says that "fully three-fourths of the Iowa delegates favor readjustment."

Hamilton county lodges are opposed to the plan and at the county camp held in this city they went on record against it, and instructed their delegates to work against it in the state camp to be held in Des Moines and to work for delegates to the National Camp who will represent their desires. The delegates chosen to the state camp

are W. J. Hubacher, vice-consul of the local lodge, and J. D. Porter, camp lecturer. These gentlemen have corresponded with scores of Iowa lodges and to them almost unanimous in denouncing the proposed plan. In fact, so far as they are able to discover, Blackhawk is the only county in favor of the plan. The delegates are now buried in such correspondence from hundreds of lodges in Illinois, Michigan, Wisconsin, Minnesota, Kansas, Nebraska and Missouri, as it is the desire of those in opposition to the proposed readjustment plan to make a united and concerted opposition such as cannot possibly be overcome.

"This Davenport dispatch is the purest fiction," said an officer high in the local lodge yesterday. "Why our local delegates have received word from a large majority of camps in all the states claimed by the Davenport dispatch to be in favor of readjustment. These reports show conclusively that the committee's plan of readjustment will be overwhelmingly defeated at Indianapolis in June at the National camp. Our reports also show most authentically that the general attorney of the M. W. A., J. G. Johnson, of Peabody, Kansas, has a large majority of the delegates pledged and will easily be elected head consul, as the candidate of those opposed to the readjustment plan. We are further in a position to say with good authority that Jerry S. Green will be elected on the board of directors from Iowa, and that Auditor J. D. Denison, of Clarion, Iowa, will be turned down, and E. R. Murphy, of Leavenworth, Kansas, elected to the position."

M. W. A. camps in this section of Iowa are all incensed over the Davenport dispatch and will now work the harder against the proposed plan of a readjustment of the rates.
