

PRICES NOT GREATLY CHANGED

WILL SELL LAKE BEDS

But Provisions of New Law Are Not What Many Have Imagined

MUST GO THRU PRELIMINARIES

Even Then Those Who Have Acquired Apparent Possession of Large Lake Beds May Not Obtain the Titles Which They Seek—Proviso Included in the Law.

Des Moines, May 12.—Persons possessed of Iowa lake beds, who have imagined that under the law passed by the recent general assembly they would receive adequate title thereto directly from the governor without any preliminaries being necessary, are doomed to disappointment.

It has been held by the attorney general that these persons must proceed as any others to secure a petition and present to the executive council the question of whether or not the lake bed in question should be sold.

This was the view which Governor Cummins took of the matter when it was first presented to him. The interested persons asked that deeds be at once made to them for the lake beds which they claim to have bought. The governor thought it necessary to go thru the preliminaries to this end provided by the new law in cases in which proceedings were inaugurated while yet the lakes were full of water.

Under the law, while the council is empowered to sell the lake beds, it is necessary, first, for fifty residents of the township in which the lake is situated, to petition the council to declare the lake in question for sale; the council must then have the lake surveyed, subdivided according to the government survey, examined by a commission or two, and appraised. Then the owners of abutting property have the right to make the first offer for the lake bed if their land has been made fractional because of the presence of the lake abutting thereon. Afterwards the lake may be sold to any person who gives the appraised price.

But a proviso is included in the law which it was claimed made it possible for the persons who already have control of title to lake beds to secure their deeds without going through the trouble of securing the petition described and allowing the council to take all of the minute steps provided for disposing of lakes newly placed on the market.

This proviso the governor thought was non-effective so far as eliminating the necessity of the petition, survey and appraisal and submitted the question to Attorney General Cummins, who has held the same view in an opinion filed with the governor Tuesday.

In effect this compels all those persons, who, like Dr. Kent and Mr. Moore in Hamilton county have acquired apparent possession of large lake beds to go through the same formalities as other persons desiring to begin action to effect the purchase of lake beds.

And, moreover it makes it possible, though hardly probable, that they may acquire the title to whether Mr. Winans intended to abandon his American domicile, but said the crowns certainly had not made out a conclusive case.

In his later years he became an ardent supporter of the movement for universal peace.

There are, therefore, infinite charm and variety in their daily life of Korea. The natives take their pleasure passively, and their constitutional incapacity makes it appear as if there were little to do but to indulge in a gentle stroll in the brilliant sunshine or to sit cross-legged within the shades of their houses. Inaction becomes them. Nothing could be more unattractive to the character of their peculiar costume than vigorous movement. The stolid dignity of their appearance and their stately demeanor add vastly to the picturesque of the street scenes. The white coat, white trousers, white socks, slowly striding population is irresistibly fascinating to the eye."

Dismissal of Young Lieut. Mills For Unbecoming Conduct. Leavenworth, Kas., May 12.—Col. Dunaan, commanding officer at Fort Leavenworth, is in receipt of a telegram from the war department saying that President Roosevelt has approved the sentence dismissing First Lieutenant Mills, who had been in the Seventh infantry from the army. Lieutenant Mills, whose home is in Albany, N. Y., has been under arrest in the hospital since December 8, soon after his return from the Philippines. He is now at liberty.

Lieutenant Mills was tried by court martial on three charges, duplicating his pay account, making false official statements and refusing to pay bills he owed to merchants. In addition he was reported to neglect his duties as a student officer last year. He was allowed to join his regiment after his college term ended, but engaged in a controversy with Colonel Miner as to his contract with a student officer. He was ordered to return to the Philippines to face a court martial when the additional charges of duplicating his pay check turned up.

CONDITIONS OF RUSSIAN LOAN. Total Issue Will be \$160,000,000, in 5 Per Cent Treasury Bonds. Paris, May 12.—Following the return of M. THE LAW IN KOREA. Queer Ways of Punishing the Relatives of Criminals. Anna Hamilton in his book on Korea says: "The inhabitants are peculiarly profane in the art of doing nothing gracefully. There are, therefore, infinite charm and variety in their daily life of Korea. The natives take their pleasure passively, and their constitutional incapacity makes it appear as if there were little to do but to indulge in a gentle stroll in the brilliant sunshine or to sit cross-legged within the shades of their houses. Inaction becomes them. Nothing could be more unattractive to the character of their peculiar costume than vigorous movement. The stolid dignity of their appearance and their stately demeanor add vastly to the picturesque of the street scenes. The white coat, white trousers, white socks, slowly striding population is irresistibly fascinating to the eye."

Here are some of the punishments prescribed by Korean law: Treason, man—Decapitated, together with male relatives to the fifth degree. Mother, wife and daughter poisoned or reduced to slavery. Treason, woman—Poisoned. Murder, man—Strangled or hanged. Murder, woman—Strangled or poisoned. Wife poisoned, Arson, man—Poisoned. Theft, man—Strangled, decapitated or banished. Wife reduced to slavery; confiscation of all property. Desecration of graves—Decapitated, together with male relatives to the fifth degree. Mother, wife and daughter poisoned. Counterfeiting—Strangulation or decapitation. Wife poisoned.

Dismissal of Young Lieut. Mills For Unbecoming Conduct. Leavenworth, Kas., May 12.—Col. Dunaan, commanding officer at Fort Leavenworth, is in receipt of a telegram from the war department saying that President Roosevelt has approved the sentence dismissing First Lieutenant Mills, who had been in the Seventh infantry from the army. Lieutenant Mills, whose home is in Albany, N. Y., has been under arrest in the hospital since December 8, soon after his return from the Philippines. He is now at liberty.

Lieutenant Mills was tried by court martial on three charges, duplicating his pay account, making false official statements and refusing to pay bills he owed to merchants. In addition he was reported to neglect his duties as a student officer last year. He was allowed to join his regiment after his college term ended, but engaged in a controversy with Colonel Miner as to his contract with a student officer. He was ordered to return to the Philippines to face a court martial when the additional charges of duplicating his pay check turned up.

CONDITIONS OF RUSSIAN LOAN. Total Issue Will be \$160,000,000, in 5 Per Cent Treasury Bonds. Paris, May 12.—Following the return of M. Hoetinguer from St. Petersburg, a semi-official statement was made yesterday of the final conditions of the Russian loan. The total issue will be \$160,000,000, in 5 per cent treasury bonds of \$100 each, redeemable in May, 1909, with interest payable in May and November, annually, and the first interest to be paid next November.

RECEIVER TO TAKE POSSESSION. Robert C. Morris to Straighten Out Affairs of F. W. Crawford & Co. New York, May 12.—Robert C. Morris, receiver of Floy, Crawford & Co., members of the Consolidated exchange, who were suspended several days ago, said that as soon as he had filed his bond and qualified as receiver which would take possession and begin the work of straightening out the affairs of the firm.

FOR ENTICING YOUNG WOMEN. Eight Indictments Are Found by St. Louis Grand Jury. St. Louis, May 11.—The grand jury yesterday returned eight indictments against M. Joseph Weipolitz, charged with enticement of young women from Germany to this country for immoral purposes. The woman, who has been arrested twice on the same charge, said, when first taken into custody Saturday that the girls were brought to this country by her to serve as waitresses in a garden for a world's fair concessionaire. She now asserts that she had nothing to do with bringing them to this country.
