NEW LAWS NOT NEEDED

STATE OF IOWA HAS SUFFICIENT STATUTES TO INSURE HIGH MORAL TONE.

MANY GOOD STATE LAWS, ALL WELL ENFORCED

County Attorneys of State Make Reply to Attorney General Byers' Questions Regarding Observance—Some Suggestions For Changes in Present Statutes.

Special to Times-Republican.

Des Moines, Feb. 19.—Law enforcement and law observance are the rule rather than the exception in the state of Iowa.

The laws are well enforced. The laws are generally good. The laws in regard to saloons, liquor sales, etc., are being generally lived up to.

The law enforcing officers differ widely as to whether or not any new legislation is needed or whether there should be repeal of some laws, according to some of their reports received by Attorney General Byers in response to his recent circular sent out to find out about these matters from the offices of county attorneys.

The county attorney of Grundy county, for instance, is not planning for more legislation. He says: "It seems to me that we have too many laws. Laws are all right, but the trouble is in regard to enforcement of them. Some of these laws are too stringent they can not be enforced to the letter. Then there is another thing to be taken into consideration—it is pretty hard to make people good by legislation. You can lead a horse to a tank of water but you can not make him drink. Society is so constituted that we must have laws, but the trouble is every fellow has a hobby and he wants a law to put his hobby in operation."

Suggestions From Cass. The county attorney of Cass county finds basis for a suggestion, and writes:

"I know of nothing the prosecuting attorney needs so badly as a law creating a special tax or fund with proper safeguards surrounding it, for the use of the office in employing assistance in securing evidence against the chronic law violators in the sale of liquors and petty thieving and gambling. I would suggest that the legislation that would do the most good to strengthen and make effective the criminal laws of the state would be some change in the criminal procedure. I would suggest an amendment to the grand jury system to the effect that while the grand jury should return indictments it should not be compulsory on the county attorney to give his evidence to the defendant nor the names of the witnesses."

The county attorney of Wapello gives it as his opinion that "the most effective prevention of crime is vigorous prosecution and speedy and certain punishment; and not too much sentimentality and leniency in the way of executive clemency."

From Sioux City Doing Something. From Sioux City comes the information that law enforcement is well in hand. The attorney says:

"With reference to the operation of the saloons in this county without having fully complied with the provisions of the malt law, I can well say that never since I have lived in the county have the saloons so literally complied with the law as at the present time. That there are violations, I doubt not, but they are not violations like those which we have had."

There are neither gambling houses nor houses of ill fame in the city. The attorney of Carroll county has a suggestion as to better law enforcement:

There should be some provisions allowing the sheriff, on the advice of the county attorney without asking the board of supervisors or any other power on earth, to spend money for the purpose of hiring secret agents to secure evidence against violators. The attorney of Pottawattamie county says that all provisions of the malt law are being observed, and neither gambling nor prostitution is permitted. He would authorize courts to "require witnesses in criminal proceedings to enter into a bond for their appearance, and there should be reform in the manner of selecting juries."

The county attorney of Linn county says: "My efforts toward law enforcement have been limited to continued and persistent prosecution of all cases of violations of law where evidence was obtainable."

Scott Doesn't Want More Law. The county attorney of Scott county has "no suggestions to make in regard to new legislation as I have found the criminal laws of the state to be sufficient in every instance."

The county attorney of Shelby county would have the calling of a grand jury optional with the judge, would extend the justice court jury, would return injunctions to gambling houses, and would permit an accused person to plead guilty without waiting for a grand jury.

The tenor of the replies received, of which the above are only a few samples, is that the laws of the state are now better enforced than ever and this is especially true of laws relating to the liquor trade, and that there is much less cause for complaint about saloons and illicit sales of liquor than ever before in the history of the state. The

DEPARTMENT MOVES FROM OLD CAPITOL BUILDING

Dedicatory Exercises on Tuesday to Be Featured by Address by Dean Kirchwey, of Columbia University—Public Reception in Afternoon—Alumni to Take Part.

Iowa City, Feb. 19.—From cramped quarters in the old capitol building, the birthplace of the state of Iowa, the law college of the University of Iowa has moved into a new home and on Tuesday, Feb. 22, marks the beginning of a new epoch in its history for on Washington's birthday the new structure will be officially dedicated.

Visitors in Iowa City who have seen other leading law schools in the middle west state that the S. U. I. building is surpassed only by the law building at the University of Chicago. The new home of the Iowa law school was built at a cost of \$130,000 and is equipped with all the latest devices for the convenience of the faculty and student body.

On the ground floor is a lecture room, a janitor's room, and a student's room for relaxation where the men may smoke if they choose. The dean's office is located on the first floor and here is also the senior lecture room and the ladies' room, indicating that the law school expects the continued registration of lady students. At the present time three young women are enrolled in the school. The second floor has a large lecture room and five offices for instructors. There is also a moot court room equipped as any modern court room in the state. The third floor is given over entirely to the law library which is declared by many to be the finest reading room in the state. The wood work and furniture throughout are of oak and stained in a shade known as early English.

The dedicatory ceremony on Tuesday will be featured by an address delivered by Dean George W. Kirchwey, of the Columbia law school. Preceding this speech the Hon. James H. Trewin in a short address will welcome and Mrs. E. F. Carroll and Hon. James H. Trewin and wife will be in the receiving line. That evening 400 alumni, students, faculty members and friends of the law school will attend a banquet at the Methodist church. Hon. Joe R. Lane, of Davenport, will be toastmaster and Mrs. E. F. Carroll will respond to toasts which will be Hon. Carroll Wright, Hon. James H. Trewin, President George E. MacLean, Dean George W. Kirchwey, Hon. James B. Weaver, Jr., Dean C. N. Gregory and Charles Frederick Luberger, of Cedar Rapids, president of the senior law class.

GADE BROS. TO RESUME. New Machinery Must Be Installed—Loss Larger Than First Estimated. Special to Times-Republican. Iowa Falls, Feb. 19.—Carl L. Gade, who is at the head of the Gade Bros. Gasoline Engine Works, which sustained such a severe loss by fire here Thursday night, stated today that the company's loss would run from \$50,000 to \$75,000 depending wholly on the ex-

tent to which some of the machinery was damaged by the fire and water. It is the intention to resume operations just as soon as new machinery can be installed, but this will take sixty days, it is thought. Another large building owned by the company, and which was completed this fall, will be used until the main building can be rebuilt and re-equipped. The company carried \$14,000 insurance.

A MONUMENT MOVEMENT.

Efforts Revived for Erection of Shaft Over Grave of First White Woman. Special to Times-Republican. Webster City, Feb. 19.—A movement is on foot and gives promise of early consummation for the erection of a monument over the grave of Mrs. Lott, the first white woman whose feet ever trod this section of Iowa. This grave is located east of Stratford, just a half mile over the line into Webster county and near the mouth of the Boone river. Funds for the erection of this monument will be donated by the Old Settlers' Association of Hamilton county and by the boards of supervisors of Hamilton and Webster counties.

A large part of the credit for the fulfillment of plans for the erection of this monument will be due to Editor F. C. Runkle, of the Staphop's Mail, who is secretary of the Old Settlers' Association. Mr. Runkle has spent some time and much effort interesting the boards of supervisors of Hamilton and Webster counties in the matter. The Hamilton county board has signified its willingness to bear its share of the expense, but has asked that the Webster county board take the initiative, as the grave of Mrs. Lott lies in Webster county.

The movement for the erection of this monument was started two years ago by the boards of supervisors of the Old Settlers' Association at Bell's Mill.

DEARTH OF CANDIDATES.

Only One in Field Thus far for Mayor, at Cedar Rapids. Special to Times-Republican. Cedar Rapids, Feb. 19.—In spite of the fact that nomination papers for the primaries, preceding the city election, must be filed before March 4, there is yet but one candidate for mayor in the field, and but ten candidates for councilmen. Mayor Miles and all the councilmen are candidates for reelection. Two years ago there were nine candidates for mayor and forty-eight candidates for councilmen; this year there will be probably no more than three or four candidates for mayor and fifteen to twenty for councilmen.

It is not yet definitely known who will oppose Mayor Miles, but among the names suggested are George Lightner, former mayor and at present walking delegate for the carpenters, and John W. Harry and Henry Bennett, prominent business men. The absence of any great issue from the campaign precludes the possibility of a very exciting contest, the old council having given very general satisfaction. Personal preferences will probably largely determine the outcome of the election.

Trewin in a short address will welcome and Mrs. E. F. Carroll and Hon. James H. Trewin and wife will be in the receiving line. That evening 400 alumni, students, faculty members and friends of the law school will attend a banquet at the Methodist church. Hon. Joe R. Lane, of Davenport, will be toastmaster and Mrs. E. F. Carroll will respond to toasts which will be Hon. Carroll Wright, Hon. James H. Trewin, President George E. MacLean, Dean George W. Kirchwey, Hon. James B. Weaver, Jr., Dean C. N. Gregory and Charles Frederick Luberger, of Cedar Rapids, president of the senior law class.

GADE BROS. TO RESUME.

New Machinery Must Be Installed—Loss Larger Than First Estimated. Special to Times-Republican. Iowa Falls, Feb. 19.—Carl L. Gade, who is at the head of the Gade Bros. Gasoline Engine Works, which sustained such a severe loss by fire here Thursday night, stated today that the company's loss would run from \$50,000 to \$75,000 depending wholly on the ex-

tent to which some of the machinery was damaged by the fire and water. It is the intention to resume operations just as soon as new machinery can be installed, but this will take sixty days, it is thought. Another large building owned by the company, and which was completed this fall, will be used until the main building can be rebuilt and re-equipped. The company carried \$14,000 insurance.

A MONUMENT MOVEMENT.

Efforts Revived for Erection of Shaft Over Grave of First White Woman. Special to Times-Republican. Webster City, Feb. 19.—A movement is on foot and gives promise of early consummation for the erection of a monument over the grave of Mrs. Lott, the first white woman whose feet ever trod this section of Iowa. This grave is located east of Stratford, just a half mile over the line into Webster county and near the mouth of the Boone river. Funds for the erection of this monument will be donated by the Old Settlers' Association of Hamilton county and by the boards of supervisors of Hamilton and Webster counties.

A large part of the credit for the fulfillment of plans for the erection of this monument will be due to Editor F. C. Runkle, of the Staphop's Mail, who is secretary of the Old Settlers' Association. Mr. Runkle has spent some time and much effort interesting the boards of supervisors of Hamilton and Webster counties in the matter. The Hamilton county board has signified its willingness to bear its share of the expense, but has asked that the Webster county board take the initiative, as the grave of Mrs. Lott lies in Webster county.

DEARTH OF CANDIDATES.

Only One in Field Thus far for Mayor, at Cedar Rapids. Special to Times-Republican. Cedar Rapids, Feb. 19.—In spite of the fact that nomination papers for the primaries, preceding the city election, must be filed before March 4, there is yet but one candidate for mayor in the field, and but ten candidates for councilmen. Mayor Miles and all the councilmen are candidates for reelection. Two years ago there were nine candidates for mayor and forty-eight candidates for councilmen; this year there will be probably no more than three or four candidates for mayor and fifteen to twenty for councilmen.

It is not yet definitely known who will oppose Mayor Miles, but among the names suggested are George Lightner, former mayor and at present walking delegate for the carpenters, and John W. Harry and Henry Bennett, prominent business men. The absence of any great issue from the campaign precludes the possibility of a very exciting contest, the old council having given very general satisfaction. Personal preferences will probably largely determine the outcome of the election.

BELLE PLAINE BREVITIES.

Two Old Residents Buried—Union Revival Meetings in Progress. Special to Times-Republican. Belle Plaine, Feb. 19.—Hans Lahn, Sr., a well-to-do farmer, aged 70, and for many years a resident of Belle Plaine, was buried Thursday at Oak Hill cemetery. He had been in failing health for about a year and confined to his bed for the past few months. Andrew Ortscheldt's body was brought here from Davenport for burial. Mr. Ortscheldt was at one time a resident of this place and in business here. He was a charter member of the Iowa Legion of Honor, No. 151, of this place.

The churches of the city are holding union revival services at the opera house, which are being well attended and will continue several weeks. They are being conducted by Evangelist Forsythe.

HARRISON COUNTY PROSECUTION
