STAMPEDE FOR GARST

MANY VOLUNTEERS CALL FOR NOMINATION PAPERS TO CIRCULATE FOR SIGNERS.

ALREADY 10,000 TO 15,000 NAMES ON PETITIONS

Progressive Committee Fairly Overwhelmed With Work—Standpats to Maintain Two Headquarters in Des Moines, One by Carroll and One by Jackson.

Special to Times-Republican. Des Moines, April 16.—The standpats are giving it out that nomination blanks sent out for Garst have been sent to Carroll unsigned. That is probably so. The progressives sent out papers to republicans with little reference to factional alignment, and very likely some fell into the hands of standpats of pronounced type. The Carroll papers were sent out to men picked carefully and supposed to all be ardently for him.

But as illustrating the way the thing works, there was received at the progressive headquarters several letters from persons who state that they had signed the Carroll papers, supposing a fight for control of the state; but now they are ready to defend the party and support Governor Garst.

One letter at the headquarters indicated the trend of affairs. It was from an appointee of Governor Carroll. He said he had circulated the Carroll papers, as requested, and he would not circulate the Garst papers, but he stated he had placed them in the hands of the best men he could find and they would be cared for. He also stated that although a Carroll appointee he would vote for Garst, as he regarded the principle involved as far more important than any personal ambition.

The Cummins-Dolliver-Garst committee is simply overwhelmed with work and volunteers are needed to help out in the correspondence. The good republicans of the state have been calling for nomination blanks and asking what there is to do. The names have not yet been counted but perhaps there are ten to fifteen thousand signers to the Garst petitions. A more remarkable manifestation of interest in the principles involved has never been seen.

It is now stated that two standpat headquarters will be nominally maintained—one by the Jackson committee, ostensibly in support of President Taft, and the other probably in charge of Mr. Murphy or one of the appointees of Governor Carroll.

Somewhat misleading accounts have appeared in the papers in regard to the long standing customs of the state board of health and that estimable body is correspondingly under fire. The attorney general was called upon for an opinion as to fees, and of course stated that the attorney general holds this is payment for expenses and it can only be used for the expense of shipment. This is a matter personal to the secretary and entirely outside of the fees of the office, hence does not appear of record. The system was one established long ago by Secretary Kennedy and has been followed for many years.

The interesting part of it is that it discloses the fact that in the last year, or within one season, there was delivered to the State University for anatomical purposes a total of fifty-three bodies, to Drake medical school thirty-six and to Still College twenty-nine. The letter follows: "To health officers, city and county authorities and women's clubs of Iowa: 'It must be remembered that the only way to prevent pandemics and epidemics of disease is to clean up, clean up and keep clean; therefore, the state board of health deems it wise that April 25 to May 1 be set apart as clean-up days for the state of Iowa. On these days let everyone make special effort at purifying our state.'

Now, in accordance with the above, I therefore call upon you to do all in your power officially and privately to rid our state of filth and its products. Let each man cleanse his premises, and each woman her house, and each officer his territory.
