SECURE GOOD VIEW OF HALLEY'S COMET

RESIDENTS OF EAST PART OF TOWN FIRST TO REPORT CELESTIAL WANDERER.

GET GOOD VIEW IN EASTERN HEAVENS

Comet Does Not Appear Large, But is Brilliant—Was Visible Also From South Part of Town, Where View Was Unobstructed—Appearance Noticed at 3:45 A. M.

The first people to report Halley's comet locally are residents of the northeast part of town, who, for the first time this morning, noticed the celestial wanderer in the northeastern heavens at about 3:45 o'clock. The comet did not appear to be as large as most people had expected, but was very brilliant. The heavens were clear, and a good view of the comet was obtained from points where there were no obstructions in the way.

From points in the south part of town the comet was also noticeable. Iowa Central men at the yard office having also reported it this morning. When it was known down town that the comet was visible to the naked eye people who were out early made an effort to get a view of it. From the street, however, the view was obstructed.

From Scientific Standpoint. For the benefit of those who may care to rise early in the hope of getting a view of the comet the following information, compiled by Prof. D. W. Morehouse, of Drake University, will be of interest. The comet can not be seen with the naked eye until about an hour later than the time given below. The velocity given relates to the number of miles per minute the comet traverses in its orbit.

This morning, May 3, the comet rose at 2:55, 96,000 miles from the earth, and traveling at a velocity of 1,929 miles per minute. Friday of this week, May 6, the comet will rise at 2:48, and will be 32,000,000 miles from the earth, and will be traveling 1,873 miles per minute. On next Monday, May 9, the comet will rise at 2:46, 44,000,000 miles from the earth, and traveling 1,824 miles per minute. On May 12, rising at 2:55 a. m., the comet will be 34,000,000 miles from the earth, and traveling 1,784 miles per minute.

SUNDAY IS MOTHERS' DAY

White Flower, Emblem of Purity, Worn on Second Sunday in May For Mothers Who Are Gone—Bright Flowers For Mothers Who Are Living.

Next Sunday, the second Sunday in May, is the day set aside the country over as "Mothers' Day." The day is as its name indicates, in memory of "our mothers," whether they be gone or living. Governor Carroll has already issued a proclamation for "Mothers' Day" in Iowa, and several mayors of Iowa cities and towns have issued proclamations of a similar nature.

The origin of "Mothers' Day" dates back only three years, and is attributed to Miss Anna Jarvis, 2031 North Twelfth street, Philadelphia. Miss Jarvis conceived the idea in the desire to commemorate the anniversary of her mother's death. It was not only the thought of laying some flowers on mother's grave, but it occurred to her that it would be a beautiful tribute to all mothers' the living as well as the dead, if their children, on a given day, would unite in the simple wearing of white flowers. She wrote a letter about it to a Philadelphia newspaper and it was this that caused Mother's day to be observed in places all over the country.

Miss Jarvis suggested the white carnation as the "Mothers' Day" flower par excellence. "Its whiteness stands for purity; its form, beauty; its fragrance, love; its wide field of growth, charity; its lasting qualities, faithfulness—all a true mother's attributes," she wrote. Public sentiment, however, has decreed that white flowers be worn for the mothers who are dead, and brighter ones for ones for the living.
