One-third cup butter; 1/2 cup sugar; 1 egg; 3/4 cup milk; 2 cups flour; 3 level teaspoonsfuls K C Baking Powder; 1/2 teaspoonful salt; scant 1/2 pound dates.

Cream the butter, add the sugar and the egg, beaten light. Sift together three times, the flour, baking powder and salt; add these to the first mixture, alternately with the milk; beat thoroughly and add the dates, stoned and cut in pieces. SPAULDING FOR SENATOR, SHERMAN FOR LOWER HOUSE

Reed of Brooklyn Chosen For County Attorney and Binegar For Sheriff—List of State Senators and Representatives Chosen From Other Districts of State.

Special to Times-Republican. Grinnell, June 8.—Poweshiek county was strongly progressive in Tuesday's primary, and nominated for representative Ralph Sherman, of Chester. For senator H. W. Spaulding, of this city, was nominated in the Poweshiek-Keokuk district. Both are strong progressives and in sympathy with the work of our senators in Washington.

Everything was quiet on the surface here, except for one street slouping in which the lie was said to have been freely exchanged between two prominent men, but the undercurrent of feeling was intense and the younger progressive element "saved word" steadily all day, but with set faces they showed they were not sure of anything until the returns were counted. The returns indicate Reed of Brooklyn for county attorney over Crosby of Grinnell; Binegar of Montezuma for sheriff over Terrell of Grinnell and Lynch of Sheridan; Corrough of Grinnell for county supervisor over Harpster of Grinnell. Later and fuller reports will change some of these apparent results. The work of counting out was unexpectedly long and tedious, the second ward not having finished until 7 o'clock this morning. A large majority vote was polled, especially in the first ward, but not the full strength of the city.

\$1,000 FOR Y. W. C. A. Cedar Rapids Donates Balance of Tabernacle Fund. Cedar Rapids, June 8.—In accordance with the suggestion made in The Gazette some days ago, the stockholders of the Sunday Evangelists Association last evening voted unanimously to appropriate \$1,000 of the \$1,032.51 remaining in the treasury of the organization to the Y. W. C. A. as the nucleus of the new building fund.

Also every subscriber to the fund had been notified by notice and thru the press, there were only about thirty present last evening. The proposition first made by The Gazette was taken up and informally discussed, without the least opposition. The vote, as has been said, was unanimous.

Originally it was planned to expend this money in another evangelistic campaign, but it is extremely doubtful whether the churches of Cedar Rapids will get together again in many years for such a series of meetings as was held under the direction of Evangelist Sunday. The suggestion that the remaining funds be given to the Y. W. C. WHERE ARE THE POLICE? Sioux City "Jack the Huggler" Keeps Annoying Girl Students. Sioux City, June 8.—A mysterious man, who has been frequenting the college campus at Morningside for several weeks, commonly known among the college students as "Jack the Huggler," appeared again last evening and frightened several of the Morningside young women. He has been a terror to the young women at Morningside, making it his program to accost individual coeds when unescorted at night, chasing them sometimes into the very college halls, and on several occasions frightening his victims into hysterics.

The boldness of the stranger has even led him occasionally on the campus in daylight at times when none of the men of the college were near, much to the fright and disgust of the young women he approached. Until last night, however, there had been a cessation of his activity for about a week, following some concerted efforts at his capture by the men. He had readily averted capture on each occasion. The event of last night proved, tho, that the audacity of the stranger has not yet reached its limit, and as a result it is likely that even more determined efforts at his capture will be made.

He is reported by the young women to have made a display of firearms on a number of occasions to emphasize the danger which would attach to any attack upon him.

SUED ON CONTRACT. Action Against Ft. Dodge Man and Bond Company. Ft. Dodge, June 8.—Suit has been filed in the district court of Webster county against John Nelson and the United States Fidelity & Guaranty Company, as a result of the failure of Mr. Nelson to complete his contract for the digging of Drainage Ditch No. 43.

Judgment in the sum of \$3,741 is asked against the United States Fidelity & Guaranty Company and \$2,657.29 against Contractor Nelson for the inability of the latter to live up to the terms of the contract, and the petition in the suit stipulates that should the judgment be given by the court the same shall become a part of the fund for the establishment and construction of Drainage Ditch No. 43.
