PHILLIPS OUSTER SUIT FILED.
Attorney General Begins Action Against Ottumwa Mayor.

Ottumwa, June 30.—Right on the heels of the Wapello county district court declaring Mayor T. J. Phillips personally liable for \$500 of the Junkin reward, Attorney General Byers filed his papers in the district court here asking for the removal of Phillips under the Cosson law.

Jacob Redman, a local pawnbroker, was declared by Judge C. W. Vermillion to be entitled to the Junkin reward which amounts to \$700.

Mayor Phillips ordered \$500 on behalf of the white Dr. D. C. Brockman and G. O. Nelson, a brother-in-law of Clara Rosen, Junkin's victim, offered \$100 each.

The Cosson law petition was placed on file yesterday. It will come up for hearing at 10 a. m. July 11. In this petition Phillips is accused of corruption in office; it is also alleged that he has permitted saloons to operate in Ottumwa contrary to law; that he had knowledge of gambling houses being operated in violation of the law; that he has licensed, permitted and authorized gambling houses in Ottumwa; that minors have been permitted to enter pool and billiard rooms. That he has refused and neglected to stop the conduct of houses of ill fame; that since his election and qualification he has repeatedly been in a state of intoxication; that on April 30, 1910, he appeared on the streets in a state of intoxication; that at said time he was boisterous and disorderly using loud and profane and obscene language.

STRANGE STORY OF DISASTER.

Dubuque, June 30.—A special from LaCrosse under date of June 28, says: James Barrett, a railroad brakeman of Miles City, Mont., in a disheveled and irrational condition, wandering into LaCrosse today, after wandering half a day since Saturday night from the scene of the wreck of the J. S. Barrett tells an incoherent story of the drowning of his wife, May Barrett, and four other women in his party, all strangers and heretofore not missing. They were en route to Salt Lake City at Lansing. The police are investigating his story, with expressions of doubt as to its reliability, although Barrett's condition tends to verify his statements. Inspectors Knapp and Carey, of Dubuque, reached the wreck and will make a thorough investigation.

PACKED LIKE SARDINES.
Fifteen Prisoners Confined in One Cell in Des Moines Jail.

Des Moines, June 30.—Released prisoners from the Polk county jail Tuesday complained bitterly of the manner in which they and others were placed in crowded cells. Fifteen men were locked, it is claimed, in one cell 12 by 16 feet in size.

William Anderson, discharged prisoner, told of conditions in the jail, and his statements were verified. Jailers admitted there were fifteen men in one cell, but claimed that number not too great, and that it was customary to house even greater numbers in a cell. Certain physicians declare such conditions very unhealthy.
