SAVE THE BABIES STATE HEALTH BOARD ISSUES ADVICE ON CARE OF INFANTS.

HEAVY MORTALITY OF LATE MOVES PHYSICIANS TO ACTION Board Tells Fathers and Mothers What to Do and What Not to Do in Cases of Illness and in Preventing Sick-

Des Moines, Aug. 10.—The state board of health has been notified from all sections of the state of the alarming infant mortality from entirely preventable causes.

The hot weather of this season of year is extremely dangerous to the lives of infants and young children, not only because of the depressing effect of high temperature in general, but especially because it is harder to preserve all articles of food, especially cow's milk, in hot weather.

Breast Milk Natural Food. In practically all cases the mother can and should nurse her own baby. Breast-milk is the natural food for the newborn baby.

Immediately after birth do not use any kind of artificial food or teats for the baby while waiting for the breast milk to come. Put the baby to the breast every four hours and give nothing else, but water that has been boiled.

Do not nurse the baby whenever it cries. A moderate amount of crying helps to develop the lungs and every baby should cry during the day. Babies who are nursed irregularly, or whenever they cry, practically always get indigestion and then cry harder from the pain.

Too Much Advice From Friends. Do not wear time. Give the baby as long as he is gaining weight and never do so except by advice of your doctor. Do not follow the advice of friends or neighbors about weaning.

keep it in bed until nursing time, because you do not want to go to the ice box for it and heat it when the baby needs it. This is certain to make the baby sick.

If a bottle-fed baby is constipated give one or two teaspoonfuls of castor oil. If this does not relieve him within four hours then consult your doctor.

Do not begin milk feeding again until the doctor orders it. Babies practically never starve and they are frequently killed by being fed after illness has gone. Every drop of milk that goes into a baby's mouth after bowel trouble begins, simply adds to the poison already there.

Do not put too much clothing on the baby in the summer. During the hot weather a thin, loose dress and a diaper are enough for day and night.

Fresh air is as important for the baby's health as fresh food. During the summer keep the baby out of doors as much as possible and keep it out of the kitchen. They frequently get sunstruck from too much heat indoors.

RUNS AWAY WITH HIS BROTHER'S DAUGHTER Pair Are Taken On Way to Storm Lake and Inmate Father Hurries Daughter Home - Accused Man, Locked Up Between Trains, Hangs Self With Belt.

Special to Times-Republican. Storm Lake, Aug. 10.—A tragedy which has been enacted here, the principals of which were prominent people of Coon township, this county, has shocked the whole community, and ruined two homes.

The infatuation of an old man for his young niece was the cause of the tragedy, which resulted in a charge of incest being filed against the former and his committing suicide in jail at Fonda.

Just how long the attachment between this ill-mated couple has been going on is not known, but the climax was reached Monday morning when information was filed in the office of Justice Moore against Herman Schuman by his brother, William Schuman, charging incest, the 16-year-old daughter of the complainant being named as the victim.

The girl's father told the officers that his daughter and brother had disappeared and asked that a warrant be issued for the arrest of the latter. Deputy Sheriff Cole was sent out on Spirit Lake with the accused brother by the way of Fonda.

At Fonda the sheriff put his prisoner in the jail while waiting for the train, and while incarcerated Schuman committed suicide by hanging himself with his belt.

Schuman family is well known and has always been highly respected in this neighborhood. Deputy Cole and the girl's father started at once in hot pursuit and discovered the pair on the way to the lake. The girl was taken home by her father and the officer started to return to Fonda with the accused brother by the way of Fonda.
