MAINTAIN ABANDON TAX

MILLAGE LEVY FOR STATE BUILDING FUND MAY NOT BE MADE.

STATE BOARD OF EDUCATION TO DECIDE QUESTION SOON

Will Pass on Millage Levy at Important Meeting to Be Held in Cedar Rapids, Sept. 7 and 8—Buildings Erected by Fund Are Now About Completed—Other News.

Cedar Rapids, Aug. 26.—Shall the millage tax of Iowa be abandoned? The question will be answered at a special meeting of the state board of education, which will be held at Cedar Rapids Sept. 7 and 8.

The millage tax was levied by the legislature ten years ago for the purpose of creating a fund to be used in the erection of new buildings and other improvements at the state university, the State Agricultural College and the State Teachers' College. The fund is created by levying a fifth of a mill for Iowa and Ames and a tenth of a mill for Cedar Falls.

The buildings which are needed for the completion of these three institutions are nearly all completed, but there still remains much work to be done.

The board is now considering the advisability of asking the next legislature to continue the millage tax for a period of five years. The fund thus created in the extra five years will, in the opinion of many board members, be sufficient to make the three Iowa institutions the most complete in the middle west.

POPULAR AUTO ROUTE.

Travel Constantly Increasing Over Iowa Transcontinental Line. Special to Times-Republican.

Belle Plaine, Aug. 26.—The number of automobiles on the transcontinental route, which passes thru Belle Plaine, increases constantly. Last Sunday fifty machines passed thru here. The signs are up all thru this portion of the line, and posts painted white every mile. The road is in excellent condition. On this portion of the line within eighteen miles are three points of great interest, which are the famous Belle Plaine artesian wells, the Chelsea watermelon patch, about seven miles west of Belle Plaine, and the Indian reservation a couple of miles west of Tama. All these varied points of interest are directly on the Iowa transcontinental automobile route.
