CAMPAIGNING IS CHEAP

GOVERNORIAL CANDIDATES' REPORTS SHOW SMALL EXPENDITURES.

PHARMACEUTICAL ASSOCIATION HAS SOMETHING TO EXPLAIN

Officers Recommended Bolt of Republican Ticket and Legislative Lobby Will Be Embarrassed—Des Moines Job Printers Again After State Printing—Cummins Preparing to Leave.

Des Moines, Nov. 19.—The theory that it is a very expensive thing to make a campaign for governor of Iowa, or other state office, was spoiled by the statements made of the various candidates at the recent election. Governor Carroll only spent less than a half month's salary getting elected and Claude Porter not quite as much. The fact that the national republican committee put \$1,000 into the fight in the Ninth district will not cause any surprise, as it was supposed it would be willing to pay even more for assurance of success there. The committee also helped in a small way in two other districts of the state, the Sixth and Second.

The legislative committee of the Iowa Pharmaceutical Association will have to do some explaining when the association next meets. A circular was sent to all druggists of the state, over the signature of the legislative committee, advising that the druggists vote for Porter for governor. While it was known that among the druggists there was much interest in the election and the members to a large extent lined up that way, they felt that it was wrong to make use of their organization. The committee includes W. R. Beck, Des Moines; Frank Clark, Ottumwa; U. S. Marshall, and others.

Some of the owners of job printing establishments in Des Moines have received the scheme to have the printing and binding for the state done by contract so that they will get a chance at it. The ordinary prices charged in Des Moines for all kinds of job work are now higher than the regular prices fixed by law, and it is only because of the state having such a large amount that the printer can afford to do it at the prices paid. This was not formerly the case, but prices of labor have gone up, and the state now follows the business methods adopted by all large concerns in the matter of printing, except that firms like the Chamberlain Medicine Company have their own printing plant and will not let out jobs here and there on contract. It is not at all probable that the problem of changing the method of having the state printing done will be reopened seriously by the legislature.

Senator Cummins went to Chicago yesterday on business and in accordance with previous engagement. He has been very busy getting ready for the coming session of congress and expects to go to Washington at an early date. It is probable that he will return during the holidays.

The biennial report of State Treasurer Morrow has just been made ready for distribution. It is a book which contains a vast amount of interesting information for Iowa people, tho' it will not reach very many of them. It does show, however, that the state has not had any debt in fact since 1899 when the last of the warrants outstanding were paid off. The nominal debt which is carried on from year to year now is only nominal and is never as much as the cash on hand. The report shows the total expenditures from the general fund for two years to have been \$4,661,573.56. It also shows that the state will raise more money by direct taxation than ever before in the next year.

The local press club gives a dinner this evening for the special purpose of fully and definitely committing the club to the candidacy of Lafe Young for senator. Governor Carroll will be present.

TWO PLANS CONSIDERED FOR RAISING OF FUNDS

Fort Dodge Capitalists Propose to Create Stock Company But Commercial Club More Favorable to Plan of Raising Money by Special Tax—Legislative Act Necessary to Permit Tax.

Nevada, Nov. 19.—Following the defeat of the \$50,000 hospital proposition at the last general election when the voters of the county refused to authorize the levy for that amount to be used for the erection of a county hospital to be erected at Ames, the Commercial Club of Story City has been investigating a proposition for the erection of a hospital in that city.

The proposition had its origin a few days ago when a gentleman from Fort Dodge showed up in Story City and began promoting a move for the location of a state Scandinavian hospital at that place. He met with the Commercial Club at once and the proposition, first to lease a temporary building and later build permanently. This the club did not take to but they at once offered a good bonus providing the permanent building was erected and they assured that the money would be forthcoming. After considering the matter for some time it was decided to petition the legislature for a special enabling act to allow the town to vote a tax to raise sufficient funds for hospital purposes.

The Fort Dodge man, assuring the club members that he had sufficient financial backing, left and the tentative offer is being considered by both sides but the Commercial Club members have become enthused over the matter and say that they will carry out the proposition whether outside capital is forthcoming or not.
