DEATH-BED CONFESSION

MRS. JENNIE PRATT SAID TO HAVE ADMITTED KILLING HUSBAND.

CALHOUN COUNTY MURDER MYSTERY MAY BE CLEARED

Mrs. Pratt and Her Dead Husband's Hired Man Once Tried For Killing Pratt — Jury Disagreed and County Attorney Dismissed Indictments — Mrs. Pratt Recently Died in South Dakota.

Fort Dodge, Nov. 30.—It is reported on reliable authority that Jennie Pratt, charged with the murder of her husband in Calhoun county four years ago, confessed to the crime on her deathbed in South Dakota, two months ago. The fact that Dr. Hayes made this announcement with interest as the case was followed closely at the time of the trial. Not only did the startling crime demand interest here and elsewhere outside the county where it was tried, but local interest was doubled because of the fact that the attorneys were identified with the prosecution.

Freud by Uncertainty. "The one thing that caused the disagreement of the jury and the dismissal of the case against Jennie Pratt, after the long, hard fought trial was the fact that Dr. Hayes would not swear positively that there was arsenic poisoning because he did not find quite enough indication of it when he made his examination, so late that the condition of the stomach was such he could not know positively," said Robert Healy, one of the attorneys for the prosecution.

"I have always been thoroughly convinced of her guilt." It will be remembered that at the time of the murder and trial, the facts were known from testimony taken, that Mr. Pratt poisoned every indication of arsenic poisoning. He had the usual thirst of one poisoned with arsenic, ate ice constantly and craved all he could get, and in many other ways showed almost unmistakable symptoms of the fact he had been poisoned.

The wife and the hired man were great friends, before and after his death and it was supposed to have been their infatuation with one another that prompted the poisoning of Mr. Pratt.

A Trick of the Trade. An interesting incident in regard to the case was revealed by Mr. Healy, who illustrated the tricks of the detective's trade, but in this case it was for naught.

A Pinkerton man employed on the case, was caught in the act of rifling the money drawer in the Pomeroy rail road station and was arrested, sent to Rockwell City and thrown into jail in a cell next that of the hired man who was implicated with Mrs. Pratt.

It was all in good faith that he was arrested, but the sheriff knew the reason of the attempt and the hired man saw to it he was not in the cell next the hired man where he could pursue his investigations.

For four days the detective worked with the man, cleverly gaining his confidence in the hope he could elicit a confession valuable to the prosecution, but the man was not inclined to tell his troubles to the extent that the detective wished.

After four days of prison fare and no favors, for fearing of rousing the suspicion of the hired man, the detective gave up his attempt in despair.

HELD TO GRAND JURY. Jesse Davis Bound Over For Assault on Galvin Home Near Scranton.

Jefferson, Nov. 30.—As the result of the attack which was made upon the home of James Galvin, a farmer living three miles north of Scranton in this county, Jesse Davis was bound over to the grand jury upon the charge of disturbing the peace by chopping the doors and windows from the home of Galvin. Warrants have been issued for the arrest of three others in connection with the assault. Their names have not been divulged by the authorities.

An axe found in the possession of Davis was introduced at the hearing to prove that markings upon the framework of the doors and windows were made by the tool. It was testified at the hearing that on Friday Davis had threatened to drive Galvin from the neighborhood and that D. V. Doran, Galvin's landlord, also had made threats against Galvin. Neighbors of Galvin are much aroused over the assault and many of them are carrying arms to protect the family from any further attempts.

RECOMMENDS COUNTY BOARDS AND SCHOOL REORGANIZATION

Says Very Small Schools Should Be Temporarily Closed—Better Safeguards for Health and Comfort of Pupils—Iowa Takes Part in Commercial Congress.

Special to Times-Republican. Des Moines, Nov. 30.—In the opinion of State Superintendent John F. Riggs, as indicated in his forthcoming report, which will be the closing report of his administration, the next general assembly "should address itself to the serious work of revising the school laws in the parts where the need of revision is most pressing." He specifies these pressing needs as follows:

A simple and efficient form of rural school organization. A county board of education with certain powers and duties specifically defined by the statute. The office of school treasurer should be abolished.

The very small schools should be temporarily closed. High school privileges should be offered all youth at the expense of the district of their residence. The salary of the superintendent of public instruction should be increased. Sundry sections of the school law

should be so amended as to remove unnecessary restrictions. The law should provide greater safeguards for the health and comfort of children.

Most of these recommendations have been discussed by Professor Riggs previously and in his public addresses. The report shows that the total cost of the Iowa public schools last year was \$13,711,457. The amount paid teachers was \$8,335,918. The school enrollment was 510,661 as against 518,446 the previous year and 548,223 ten years ago. The public school enrollment was divided last year as follows: Rural schools, 249,680; graded schools, 215,746; high schools in towns less than 1,000, 16,969; in larger towns and cities 28,268.

Iowa took a somewhat prominent part in the sessions of the Trans-Mississippi commercial congress held in San Antonio last week. Senator Joseph H. Allen, of Pocahontas, was made second vice president of the congress and he and Senator Robert Hunter, of Sioux City, were made members of the executive committee. The new congress is to be held at Oklahoma City. The congress pronounced emphatically against the proposed freight rate raise and asked congress for an act to provide for an inquiry into the value of railroad property and also the actual investment.

It is probable that if Paul Stillman is elected speaker and makes a record that is anything like as good as a long line of able speakers of the past he will become a candidate either for governor or member of congress. There is also some talk of the rounds that Senator Berry, of Indiana, will become a candidate for governor next time. It is also said that if Senator Gilliland is made chairman of the judicial committee and therefore virtually leader of the state senate he will be a candidate for governor before the primaries.

Gen. James B. Weaver voted for Governor Carroll at the recent election and all effort to figure out the majority for the governor must include not only the vote of General Weaver but a great many other democrats who probably followed him. One who recently visited the general says he has no apologies for having voted for a republican for governor and he is convinced that democratic votes contributed largely to his majority.
