At no time has the situation changed in the least. The selection of Young to be the standpat candidate by action of the governor was intended to forestall all others. The candidacy of Kenyon was launched prior to the election and for some time has been a pretty clear field. Mr. Eyers' candidacy was practically announced some weeks ago by his interesting letter discussing the issues involved. On Saturday the candidacies of Funk and Garst were launched, each in a different way, and yet with certainty that both will be fairly and honorably presented to a conclusion. The other two may well be classed as possibilities yet. Both Feely and Franke are candidates and must be reckoned with.

The home in Toledo, with all contents, also five acres of land near by, worth about \$15,000 in all, goes to the adopted daughter, Mrs. J. L. Lupton, of Toledo, as well as 100 acres of the Clark land in Buckingham township. All the balance is put in trust, Mr. and Mrs. Lupton and John Melser to be the trustees.

The income of half of this trust fund is to go to the daughter as long as she lives and half to her children until her death. Twenty-one years after her death the fund is to be equally divided among the Lupton children and their heirs. The estate is worth perhaps half a million dollars. It includes 2,900 acres of Tama county land.

CHURCH TO BUILD BLOCK.

Baptists at Sioux City Plan Temple Which May Include Theater.

Sioux City, Jan. 2.—The membership of the first Baptist church will, within a year or two, build a new church, that quite probably will be a combination of institutional church and business block, to cost not less than \$100,000, on the present site, Fifth and Nebraska streets. At the annual meeting of the church society, a committee was appointed to investigate the possibilities of such a building, constructed on the lines already laid down by Tremont Temple, Boston, and the principal Baptist church of Los Angeles, Cal. There may even be a theater as a part of the building, regulated to give a class of plays of unimpeachable moral tone. This is done in the Los Angeles church building with gratifying success. The building would be set aside for all the various church activities, including reading rooms, gymnasium, parlors, etc., and the remaining space in the building would be devoted to offices, stores and, perhaps, a theater.

LAX QUARANTINE LAW.

Case in Point Where State Seems Powerless to Isolate Cases.

Special to Times-Republican. Mason City, Jan. 2.—It now appears that the state of Iowa is powerless to enforce quarantine measures in even the most virulent contagious diseases. Will Skiff, a prominent stock buyer of this city, broke out with the smallpox and the health officer ordered him to be taken to the detention hospital at the outskirts of the city. Mr. Skiff accompanied the officer, but on looking over the situation and consulting with his attorney, decided he wouldn't stay there and then went to the home of a friend, where he now is. It is now claimed that there is no law in this state at the present time which compels a person afflicted with contagious disease to be isolated. On account of the prominence of Mr. Skiff the action he has taken has caused considerable comment in regard to the laxity of the present quarantine laws in this state.
