FARMERS RAISE SUGAR BEETS.

Industry Becomes General in Neighborhood of Kanawha. Special to Times-Republican. Kanawha, May 5.—Sugar beet business is becoming the principal talk on the streets of Kanawha. Nearly 400 acres of sugar beets will be planted this season. Last year C. Z. Ranken and son put in twenty-nine acres on which they realized a clear profit after paying all expenses, land rent, labor, etc., of \$900. Ferd Knoll had six acres last year which netted him \$300. This made the neighboring farmers take notice, and this year nearly 400 acres of sugar beets will be put in. The Waverly Sugar Company have the contract to buy the crop at a fixed price F. O. B. Kanawha, and will erect an elevator to load the beets into the cars.

The sugar company also furnish help to take care of the crop and move them, and fifty people are here to do the work. They are coming in whole families, and every farmer who has a beet field will be assigned one family to take care of the beet plant and this place for them to live in. Most of them here have built some cheap houses, about 16x24, that can be used later if not wanted again for this purpose, for granaries.

ROAD WORK PROGRESSING.

Rapid Progress Being Made on Automobile Tourist Road. Special to Times-Republican. Goodell, May 5.—The automobile tourist road which is being established from Des Moines to Clear Lake is developing along this part of the route with great interest. There was some talk of the road going east from Belmont to Des Moines and thence to Clear Lake but upon investigation the road is much better and straighter to go straight north of Belmont by way of Goodell, Klemme and Garner which are all on a line due north from Belmont, and thence straight east from Garner to Clear Lake; work on the road is going on in fine shape, hills are being cut down, ravines and low places filled in and graded, cement culverts are being put in from here to Garner and the road in general being dragged and looked after in good shape; consequently it will be a good route for the tourists.
