

TIE UP WITH PROHIBS

PROGRESSIVE STATE CONVENTION ADOPTS RADICAL LIQUOR PLANK.

PLAN OF COMMITTEE FOR STRADDLE IS BEATEN

Committee Wrestles With Question Many Hours and Finally Reports Mild Plank Declaring in Favor of Submission of Question to Vote, Which Convention Rejects.

Special to Times-Republican. Des Moines, July 9.—From more than one standpoint the convention of the progressive political party was a success.

The leaders expressed themselves as immensely pleased with the attendance. It was more than might have been expected considering the vote at the primary. There were seventy-three counties represented and at the height of the convention actual count showed 198 present and participating.

The last hour of the convention proved that it was not following any prearranged program. Nobody bossed the job.

There was also abundant signs of intellectual acuteness in the convention. There was no hesitancy about expressing diverse views and speaking plainly.

Also there was a great abundance of speaking. The party is well equipped with all the oratorical ability needed to carry it thru the campaign.

The only feature of the convention was the matter of adoption of the platform. There was nothing else to do. The convention listened for an hour and a half to the speech of the temporary chairman before lunch. Until a quarter to six in the afternoon, while waiting for the committee on resolutions to bring in two reports. It listened to speech making, by Judge Norton, Judge Quarten, Mr. Patton, Mr. Kugler, Mr. White, Mr. Betty, Mrs. Byram and others.

Big Light on Liquor.

The entire work of the resolutions committee was devoted to framing up the expression of the party as to prohibition. That fact seemed to be pretty clearly established when, near the finish, the convention struck out a plank which had been reported favoring the guaranty of bank deposits. It was explained by the chairman of the resolutions committee that he didn't want anybody knowing it was there, and later he said he had canvassed members of the committee after they had come to the convention hall and found nine were opposed to it and the other one he found was for it. So the resolutions committee received no consideration in the committee.

The committee reported resolutions which favored submission of the prohibition question, state and nation, to vote.

Two members of the committee, T. A. Kinsland and Frank Betty, of the Tenth and Sixth districts, reported a substitute plank declaring the manufacture and sale of intoxicating liquors as a beverage to be an economic and social evil, and therefore favoring the adoption of prohibition amendments, state and national.

Settlement Divided. That the coming storm was scented had been shown by debate even before the committee came to the hall. Mr. Patton, of Grinnell, candidate for congress in the Sixth, had declared for a strong plank, and out-and-out prohibition, without any question. He wanted the party to take a stand for something definite and gave warning that any negative plank would be unsatisfactory. Judge Quarten had taken an opposite view and declared that to adopt prohibition meant a division in the party and would be a fatal error. After the resolutions committee reported debate was shut off by a gag rule. A motion to lay the whole platform on the table, or rather to table the substitute, which would have tabled the whole report, was defeated 33 1/2 to 35 1/2. Then the substitute was adopted 58 to 22. This was a vote by counties and about 150 delegates actually took part. But on a viva voce vote the result would not have been greatly different.

During the day the sole topic of conversation was the plan to hitch up and amalgamate with the prohibitionist party. It was the one thing the delegates seemed most interested in. There was a great deal of talk and some of it in very good nature. But the convention accepted the result with apparent good grace and the plank will be defended in the state campaign.

Special to Times-Republican. Des Moines, July 9.—The board of control is at Anamosa today making investigation into the problem of industries at the state reformatory.

The desire is to reformatory a number of industries and to furnish the prisoners with varied labor. There are a number of minor industries carried out at the reformatory but nothing like what has been contemplated by acts of the legislature. There is the stonecrusher which is a valuable property and the sole remaining contract industry is the butter tub factory. The state may take over this latter and operate it.

The board will also look into the possibility of establishing some day working industries. If the right kind of clay can be secured there will be established a tile and brick factory for the work of the prisoners. It is believed this would be most easily established of any.

The legislature contemplated establishment of a number of industries at the reformatory but has never given the money with which to get started. Those that are started will have to be in a small way and at little expense.
